Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

NAGA BATTLEGROUND INC. (NBG) CONSISTS OF 2 MAIN BUSINESS ACTIVITIES NBG has united an Emmy-Winning sports media and management team with the expertise of the leading global grappling association, The North American Grappling Association (NAGA) to form the new NAGA Battleground Inc. NBG Live Pro BJJ Events showcase elite teams and individuals from around the world and plans to stream and televise its events globally via networks such as NBC Sports and ESPN. Streaming

events may also be broadcast on platforms such as Triller, and Amazon Prime. The 2026 season is expected to launch with our World Championship event at Mohegan Sun Casino on January 23. NBG Amateur Tournaments unite the expertise of NAGA, founded in 1995, which has held over 1,500 events internationally, attracting more than 1 million competitors worldwide. Our strategy introduces the fast-growing sport of Brazilian Jiu-Jitsu and grappling to a worldwide audience with high-quality broadcasting through network television and streaming.

NAGA Battleground currently has 2 employees.

Risk Factors

7. Material factors that make an investment in NAGA Battleground, Inc. speculative or risky:

- 1. We are highly dependent on the services of our founders. Our future business and results of operations depend in significant part upon the continued contributions of our CEO and COO founders. If we lose those services or if they fail to perform in their current position, or if we are not able to attract and retain skilled employees in addition to our CEO and the current team, this could adversely affect the development of our business plan and harm our business. In addition, the loss of any other member of the board of directors or executive officers could harm the Company's business, financial condition, cash flow and results of operations.
- 2. Start-up investing is risky: Investing in startups is very risky, highly speculative, and should not be made by anyone who cannot afford to lose their entire investment. Unlike an investment in a mature business where there is a track record of revenue and income, the success of a startup or early-stage venture often relies on the development of a new product or service that may or may not find a market. We may run out of money before we can execute our business plan. Before investing, you should carefully consider the specific risks and disclosures related to both this offering type and the Company.
- 3. Niche Audience Our focus is exclusively on the sport of Jiu Jitsu, which currently appeals to a specialized and smaller audience compared to other mainstream sports. Because of this, revenue from ticket sales, broadcasting, sponsorships, and merchandise may be limited or slower to grow than anticipated. We may also face challenges in converting viewership or fan engagement into consistent income. If our efforts to expand our audience and monetize events are unsuccessful, our financial performance may fall short of projections, and we may not achieve profitability.
- 4. Competition for Elite Athlete Participation We operate in a competitive landscape where multiple promotions, leagues, and events vie for the participation of top-level Jiu Jitsu athletes. These athletes often have multiple options when deciding where to compete, and their decisions may be influenced by factors such as prize money, exposure, sponsorship opportunities, event prestige, and scheduling. If we are unable to offer a compelling value proposition compared to other organizations, we may struggle to attract or retain elite talent. This could limit the caliber of our events, reduce fan

- engagement, and negatively affect ticket sales, media coverage, sponsorships, and overall brand growth.
- 5. Event Execution Our business relies on the successful planning and execution of live tournament events. These events involve coordination of athletes, production teams, venues, logistics, and safety protocols. Any issues such as scheduling conflicts, equipment failure, weather disruptions, or vendor unreliability could result in poor audience experience, reputational damage, or financial loss. We may also face challenges scaling our operations across multiple cities or jurisdictions, which could limit our growth potential or result in increased costs and operational inefficiencies.
- 6. Our Business May Be Adversely Affected by General Economic Conditions Our success depends in part on the willingness of fans, sponsors, and media partners to spend on live entertainment, sports content, and related advertising. In periods of economic uncertainty, inflation, or recession, consumers may cut back on discretionary spending such as event tickets, merchandise, or streaming subscriptions. This could reduce our revenue and slow our ability to grow a loyal fan base. In addition, potential sponsors and media partners may be less likely to commit marketing dollars or licensing fees during economic downturns, especially for new and emerging sports properties. Broader economic instability may also affect our ability to expand into new cities or regions, hire staff, or secure necessary funding for growth.
- 7. Potential for Increased Maximum Offering Amount We may choose to increase the maximum offering amount permitted in this fundraising campaign, subject to legal limits and platform approval. While doing so could allow us to raise additional capital to support our operations or growth initiatives, it also poses certain risks to investors. Increasing the offering size could lead to additional dilution for existing shareholders, as more securities would be issued. Furthermore, a larger raise may signal a greater capital need than initially anticipated, which could raise questions about the adequacy of our current financial strategy or projections. Investors should be aware that the dynamics and assumptions of the offering may change if the maximum raise is increased.

10. How will the issuer complete the transaction and deliver securities to the investors?

In entering into an agreement on the Netcapital Funding Portal to purchase securities, both investors and NAGA Battleground, Inc. must agree that a transfer agent, which keeps records of our outstanding Common Stock (the "Securities"), will issue digital Securities in the investor's name (a paper certificate will not be printed). The Company has granted a perpetual waiver of the transfer restrictions listed in the bylaws of the Company for all Securities sold in this Offering.

The Company's bylaws can be amended by the shareholders of the Company, and directors can be added or removed by shareholder vote.
