Investing in a film is inherently a high-risk venture. The film industry is constantly evolving, and business models that succeed for one project may not be applicable to another. The success of a film is often influenced by external factors beyond the control of the company.

Potential need for additional funding - While we have carefully planned our budget, unforeseen circumstances may arise that require additional funding beyond our initial projections. As a new company, we may not always allocate capital with maximum efficiency, which could lead to a need for further financing to sustain operations and meet future requirements. If we are unable to secure additional funding when needed, it could significantly impact the project and our ability to move forward. Additionally, raising more capital may result in dilution of existing investments. While we do not currently anticipate needing extra financing, we cannot guarantee that it won't be necessary.

Film production costs can often exceed initial estimates due to unforeseen circumstances beyond our control. Factors such as weather delays, equipment failures, artistic changes, labor disputes, regulatory issues, or unexpected setbacks can drive up expenses. While we plan to work with experienced professionals to keep the project on budget, there is always a risk of overspending or delays, which could negatively impact the film's profitability and overall success.

Risk of Loss in the Event of Dissolution - If the company were to dissolve or cease operations, any remaining assets would first be used to pay off outstanding debts and obligations. Only after satisfying these claims would any remaining funds be distributed to investors. As a result, there is no guarantee that investors would recover all or even part of their investment in such a scenario.

Potential Tax Implications - Investing in the company may have various federal, state, and local tax consequences that could impact each investor differently. We strongly encourage all potential investors to consult with their own tax advisors to fully understand how this investment may affect their individual tax situation and determine if it is suitable for them.

Long-Term Investment Horizon - The process of producing and distributing a motion picture takes time, often spanning several years. Even after completion, revenue generation through distribution and exhibition can be slow, and there is no guarantee of profitability. Investors should be prepared for a long-term commitment, as returns, if any, may take years to materialize.

The film industry is constantly evolving due to rapid technological advancements, emerging distribution platforms, and shifting consumer preferences. These changes can impact the potential revenue and profitability of the film in unpredictable ways. Some distribution channels may not gain the public acceptance expected, while others may become dominant, potentially reducing demand for traditional platforms like DVDs or theatrical releases. While we will strive to adapt to industry trends and leverage new distribution opportunities, we cannot guarantee success in navigating these changes, which could materially impact the project's financial outcome.

Securing a broad theatrical release can be difficult due to the competitive nature of the industry and limited screening availability. Larger studios and established distributors often dominate theater slots, which may limit our film's exposure. If we are unable to secure widespread distribution, it could impact the film's visibility and potential revenue. While we will pursue multiple distribution avenues, success in theatrical release is not guaranteed.

The managers, production team, and talent involved in this project are not exclusively dedicated to the company or this film. They may be involved in other productions, business ventures, or future projects that could compete for their time and attention. Additionally, managers may have a financial interest in the company, and any agreements they enter into with the company may not always be the result of arm's-length negotiations. While we are committed to the success of this project, these potential conflicts of interest could impact decision-making and resource allocation.

As with most films, the success of our project will depend significantly on how it is received by audiences and critics. If our film receives mixed or negative feedback, it could make it more challenging to achieve profitability. Public sentiment can be unpredictable, and adverse reactions may affect crowdfunding support, distribution opportunities, and overall project viability. While we will strive to manage our public image, we cannot control all external factors that may influence the film's reception. While our entire team is confident in the project, even the most well-intentioned productions face unexpected challenges. However, psychological thrillers are one of the few genres that continue to thrive, thanks to a dedicated fan base with preferences that often differ from those of critics and mainstream

audiences.

Our company is a newly established venture and, like any startup, faces the challenges of building a business from the ground up. We have limited operating history and minimal financial resources, which come with inherent risks. Although we are passionate and committed to delivering a quality product by partnering with our friends who have made successful independent films in the past along with other industry professionals to set up our production for the best possible results, investing in this company is highly speculative, and there is a risk that investors may lose some or even all of their investment. There are no guarantees of financial returns, and potential investors should carefully consider their risk tolerance before committing funds.

The target amount for our raise is \$350k, but if we do not raise that amount production, we will still be able to account for a smaller production value and budget at \$50k. A higher raise would allow us to cast more A-list actors, provide our team with the best support and equipment, as well as enable us to create a more comprehensive marketing campaign for the release of the film. Raising \$50k would still allow us to produce the film, but we would miss out on some of these high-value additions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

USE OF FUNDS

9. What is the purpose of this offering?

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$50,000**

Use of Proceeds: 40%: Production (camera, equipment, locations, crew, catering). 35%: cast (actors, travel, lodging) 15%: Post-production (editing, colors, sound, music rights) 79%:

production (editing, colors, sound, music rights), 7.9%: Wefunder fees. 2.1%: Reserve capital (festival submissions, misc.) - We can make this film on a micro-budget level; however, in order to pay our cast and crew properly and spend a bit on marketing for the release, it would be highly beneficial to raise more money.

If we raise: **\$1,235,000**

Use of Proceeds: The "death zone" in film financing is "200k-750k" so the production budget should be under 200k or over 750k. So, for example, if we raise 500k, we would use 195k for the production budget and keep the rest for post-production and marketing to decrease risk and increase profit potential. Raising 1 million would allow us to attach more A-list actors and provide our cast and crew with the best possible equipment, resources, and distribution to make the film profitable. 40%: Production (camera, equipment, locations, crew, catering). 30%: cast (actors, travel, lodging) 20%: Post-production (editing, colors, sound, music rights). 7.9%: Wefunder fees. 2.1%: Reserve capital (festival submissions, misc.)

If we reach our target offering amount prior to the deadline, we may conduct an initial closing of the offering early if we provide notice about the new offering deadline at least five business days prior to the new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). RECOUPMENT. Provided that Company has completed the Offering, and Financier is not in breach of this Agreement, Company agrees to repay to Financier the Financing Amount, together with a thirty-two (32%) premium for "VIP and Early Bird Investors" i.e. Wefunder VIP investors and the first One Hundred Thousand (\$100,000) invested. All other investors will receive a 120% premium thereon ("Financier Recoupment"), solely from Gross Receipts (if any) in accordance with this Paragraph.

Gross Receipts, if any, of the Picture shall be allocated in the following order:

First, to the payment of the following:

i. Any actual third party, out-of-pocket sales fees and sales expenses payable to the sales agents engaged to sell the Picture and other third party distribution fees and expenses (including but not limited to reasonable outside attorney fees) actually incurred and not otherwise recouped by Company relating directly to the Picture, ongoing third party, out-of-pocket accounting costs and expenses incurred by Company in connection with the processing of payments to profit participants on the Picture; All other costs, expenses and charges actually incurred and paid by the Company (or any affiliated or related entities) in connection with the production, post-production of the Picture or any rights therein, including, but not limited to, actual, out of pocket third party delivery costs and expenses (exclusive of the budgeted delivery costs), actual, out of pocket third party reasonable festival expenses (e.g., publicist, accommodations for producers, etc.), guild royalties, residuals, the gross amount (net of any insurance proceeds in connection therewith) paid for the settlement of any claims or lawsuits, including all expenses, court costs and attorneys' fees in connection with any such claim or litigation; but only to the extent any of the foregoing have not previously been paid or assumed by the Picture's distributor;

ii. Third party, out-of-pocket expenses incurred by Company in connection with the ongoing ownership of the Picture, including but not limited to (e.g., insurance premiums, the preservation and storage of negatives and master prints of the Picture, and copyrighting of the Picture) and maintenance and filing fees required to maintain Company in good standing; taxes and other fees; and any amounts required to be withheld by law, if any; and

iii. Any compensation or deferred compensation and bonuses (e.g., box office bonuses, award bonuses) payable to parties rendering services in connection with the Picture (to the extent not assumed by the distributor(s) of the Picture); market rate compensation payable to the Company or its affiliates for services rendered in connection with the production, completion and delivery of the Picture; any amounts paid to the completion guarantor of the Picture (if any) in repayment of sums advanced by such completion guarantor; any reasonable reserve amount, as determined by Company in its good faith business judgment, required to cover anticipated future costs or liabilities, provided that such reserve amounts shall be liquidated every twelve (12) months

Next, to the payment of any loans, plus reasonable interest thereon;

i. Next, to Financier and any additional financiers (whether such financiers participated in the Offering or through a prior or future private or other capital raise) pro rata pari passu in accordance with their respective funds provided, until all financiers, including Financier, have received one hundred percent (100%) of the Financing Amount, plus a premium of thirty-two percent (32%) of the funds provided by such financier, if ever;

ii. Next, for the payment of any actual Deferments, which deferments shall not exceed 20% of the final budget of the Picture. As used herein, "Deferments" shall mean arrangements for the deferral of some or all of the costs of goods and/or services in the Production Budget provided by the supplier of such goods and/or services; and

iii. Finally, to Net Receipts. "Net Receipts," as used herein, shall mean One Hundred Percent (100%) of all Gross Receipts remaining after the payments of all amounts set forth in subparagraphs 6(a) through (d) above. Company shall receive Fifty Percent (50%) of Net Receipts ("Company's Net Receipts") and the other Fifty Percent (50%) of Net Receipts shall be "Financier's Net Receipts." Financier shall receive such percentage of Financier's Net Receipts equal to the percentage that the Financing Amount advanced to Company represents to the actual Production Budget, which may exceed the estimated Production Budget as set forth herein.

VIP Bonus: Elmwood Park Film LLC will offer a discount to the normal terms listed in this Form C for all investments that are committed by investors who are part of Wefunder, Inc's VIP program. This means eligible Wefunder investors will receive a discount for any securities they purchased in this offering. Our sales team plans to negotiate the international sales of the film to cover all production costs so that when the film is sold/distributed regionally we will be profitable.
