<u>Summary of Application</u>: Applicants request an order to permit certain registered closed-end investment companies that intend to elect to be regulated as business development companies to issue multiple classes of shares with varying sales loads and asset-based distribution and/or service fees.

<u>Applicants</u>: Third Point Private Capital LLC and Third Point Private Capital Partners <u>Filing Dates</u>: The application was filed on June 4, 2025.
