Lit Motors is an **electric vehicle company**, and it's exposed to all macro-economical risks that other EV and general vehicle companies are exposed to.

Lit Motors is a B2C Startup Electric Vehicle company with a disruptive product that has yet to provide hard data (finalized product) for its product market fit and adoption rate in identified SAM SOM EVG.

Lit Motors stability technology has not been validated on a production level prototype and the drive by wire steering / augmented steering has not been developed for our specific application.

Lit Motors has not yet produced a production level product. The manufacturing risks for quality and reliability have not been substantiated or met vehicular safety standards yet.

Lit Motors is an automotive company with a product that has 1/10th the parts count of a car. The product's unique supply chain strategy has not been established and is a future liability yet to be secured.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The lease expires on September 30, 2026, but allows for one renewal option for an additional 5 year term. The expected monthly lease payments are \$20,000 and the lease bears an annual interest rate of 18%. In lieu of making monthly payments, the expected monthly lease and interest payments are aggregated and captured in a convertible loan with the related party. Accrued lease liability included in the convertible loans balance as of December 31, 2022 and 2023 are \$270,00 and \$486,000, respectively. The accrued lease liability includes accrued interest of \$72,537 for 2022 and \$56,695 for 2023.

The Company's business strategy includes a dual-market approach, combining business-to-consumer (B2C) and business-to-business (B2B) channels. The B2B strategy includes opportunities in satellite, robotics, and aerospace sectors that utilize CMG-based motion control, while the B2C strategy targets the urban mobility and micromobility markets

To-date, the company has been financed with \$7,774,605 in convertibles and \$2,465,248 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 12 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 3 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the

Runway & Short/Mid Term Expenses

Lit Motors Corporation cash in hand is \$3,200, as of February 2026. Over the last three months, revenues have averaged \$500/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$48,733.65/month, for an average burn rate of \$48,233.65 per month. Our intent is to be profitable in 60 months.

We have not had very much material change since the end date of our reported finances. What we have accomplished is as follows: We completed a successful 1st Wefunder crowdfunding campaign. We validated our core technology on a small scale and demonstrated this at ARPAE in Washington DC. We completed a financial audit with a certified auditor as required by the SEC. We added two part time engineers to the controls team. We maintained 26 patent annuities. We added a new financial advisor. We increased our pre orders by approximately 617.

To date, the only revenue has been from merchandise sales. We expect to begin generating additional revenue in 18-20 months. We estimate our merchandise sales rate to remain the same over the next 3-6 months or slightly increase as we continue to promote our crowdfunding campaign. We need \$11-18M to move forward with the beta development and low volume production as outlined in our contract with Ideenion. We expect expenses to be \$200k-\$5M in the next six months, depending on how much we raise in this offering.

Lit Motors is not yet profitable. We will need \$320M to get to serial production (Maximum output of 50,000 vehicles per year). With current data, we're expecting to reach this point in 4 to 5.5 years to be net income positive at 10,000 vehicles produced and sold per year. Our goal with our Ideenion partnership contract is to develop and produce a production ready vehicle that can pass EU NCAP homologation requirements. Our five year process is as follows: Yr 1 - BOM, factory plan, Tooling & Supply chain strategy, NCAP readiness, Beta prototype dev (-\$11M infusion) Yr 2 - Customer feedback / testing Yr 3 - Supply chain / tooling (-\$40M) Yr 4 - Production 1000 units (-\$250M / +32M rev) Yr 5 - Production 10,000 units (+\$320M revenue / net income +)

Lit Motors' only other sources of capital at this time is through our syndicate of private investors we've relied on for 15+ years. We are not yet profitable, and will continue to rely on private investments and merch revenue to cover short-term burn throughout the campaign. We plan to access some of the funds raised so far to cover operating and prototype development costs. There will be additional capital through new private investments, merchandise, and/or development and production of our electric scooter.

All projections in the above narrative are forward-looking and not guaranteed.
