A crowdfunding investment involves risk. Investors should not invest any funds unless they can afford to lose the entire investment.

In making an investment decision, investors must rely on their own examination of the issuer and the terms of the offering, including the merits and risks involved. These securities have not been recommended or approved by any federal or state securities commission or regulatory authority. Furthermore, these authorities have not passed upon the accuracy or adequacy of this document.

The U.S. Securities and Exchange Commission does not pass upon the merits of any securities offered or the terms of the offering, nor does it pass upon the accuracy or completeness of any offering document or literature.

These securities are offered under an exemption from registration; however, the U.S. Securities and Exchange Commission has not made an independent determination that these securities are exempt from registration.

Our platform will facilitate ticketing transactions and vendor payments, which subjects us to various federal and state regulations governing money transmission, payment processing, and potentially escrow services. Depending on how our payment systems are structured, we may be required to obtain money transmitter licenses in multiple states, comply with anti-money laundering regulations, implement know-your-customer procedures, and adhere to consumer protection laws. The regulatory requirements for handling customer funds are complex, vary by jurisdiction, and are subject to change. Failure to comply with applicable regulations could result in significant fines, penalties, cease-and-desist orders, or criminal liability. We may also face regulatory scrutiny regarding how we hold customer funds, the timing of payouts to vendors, and our disclosures to consumers. Achieving and maintaining compliance will require significant legal and operational resources that we may not have, and any regulatory action against us could severely damage our reputation and business.

Our platform will collect, store, and process personal information about event organizers and attendees, including names, contact information, payment information, and potentially other sensitive data. This subjects us to various federal and state data privacy and security laws, including state data breach notification laws, the California Consumer Privacy Act, and potentially other emerging privacy regulations. We must implement appropriate technical and organizational measures to protect this data from unauthorized access, use, or disclosure. Any data breach, security incident, or unauthorized access to customer information could result in significant legal liability, regulatory penalties, mandatory notifications to affected individuals, and severe reputational harm. As a small company with limited resources, we may lack the expertise and infrastructure necessary to implement enterprise-grade security measures. Compliance with evolving data privacy regulations will require ongoing investment in legal counsel, security infrastructure, and operational procedures, which may strain our limited financial resources.

Our business will depend on proprietary technology, software code, user interface designs, and business processes. We have not disclosed whether we have obtained any patents, trademarks, or other formal intellectual property protections. As an early-stage company, we likely rely primarily on trade secrets, confidential information, and potentially copyright protection for our software. These forms of protection may be insufficient to prevent competitors from copying our ideas, features, or approach. Additionally, the event management and ticketing space is crowded with existing players who may hold patents or other intellectual property rights. We could face claims that our platform infringes on the intellectual property rights of others, which could result in costly litigation, licensing fees, or the need to redesign our product. We may lack the financial resources to adequately defend against such claims or to enforce our own intellectual property rights against infringers. Any intellectual property disputes could significantly harm our business and financial condition.

Investors in this offering will receive a Simple Agreement for Future Equity, or SAFE, which is not a debt instrument and does not have a maturity date or require the company to repay the investment amount. The SAFE will only convert into equity securities upon the occurrence of specific future events, such as a future priced equity financing or a liquidity event. If these triggering events never occur, your SAFE may never convert into equity, and you may never receive any return on your investment. The company is not obligated to raise a future financing round or pursue a liquidity event. Even if conversion does occur, the terms of the conversion will depend on the valuation and terms of the future financing, which are currently unknown and will be determined by future negotiations between the company and future investors. The valuation cap and discount rate in your SAFE provide some downside protection, but there is no guarantee that the conversion will result in a favorable outcome for SAFE holders. You should understand that purchasing a SAFE is highly speculative and you may lose your entire investment.

The securities being offered have not been registered under the Securities Act of 1933 or any state securities laws and are being offered pursuant to exemptions from registration requirements. As a result, you will be subject to significant restrictions on your ability to resell your securities. You will be required to hold your securities for at least one year from the date of purchase, and even after that period, resales will be subject to strict limitations and conditions. There is no public market for these securities and none is expected to develop. The company has no plans to list its securities on any exchange or quotation system. Even if you are legally permitted to sell your securities, you may be unable to find a buyer willing to purchase them at any price. You should be prepared to hold your investment indefinitely and to bear the financial risks of your investment for an indefinite period of time. The lack of liquidity may make it impossible for you to recover any portion of your investment, even if the company is performing well.

Rock My Reunion, Inc. will require substantial additional capital beyond this offering to fund its operations and growth. The company will need to raise additional financing through the sale of equity securities, convertible debt, or other instruments. Each time the company issues additional securities, the percentage ownership of existing investors, including SAFE holders after conversion, will be diluted. Future investors may negotiate terms that are more favorable than those available to current investors, including lower valuations, enhanced rights, or liquidation preferences that prioritize their returns over yours. The company may also issue securities to employees, consultants, or advisors as compensation, which will further dilute your ownership. There is no limit on the amount of securities the company may issue in the future. Given the company's early stage, pre-revenue status, and substantial capital needs, significant dilution is highly likely. Additionally, as a holder of a SAFE or common stock after conversion, you will have no liquidation preference, meaning that in the event of a sale or liquidation of the company, you will only receive proceeds after all debts and preferred stockholders are paid in full. There is a substantial risk that you will lose your entire investment.

In this offering, the founder of Rock My Reunion, Inc. has designated themselves as the lead investor who will sign documents and make decisions on behalf of all investors in the special purpose vehicle. This structure creates a significant conflict of interest because the founder has interests both as the operator of the company and as the representative of the investors. Decisions that benefit the company or the founder personally may not align with the interests of crowdfunding investors. For example, the founder may have incentives to approve transactions, amendments, or corporate actions that favor the company's ability to raise capital or continue operations, even if such actions are dilutive or otherwise disadvantageous to investors. The founder will also have access to material non-public information about the company's performance, financial condition, and prospects that other investors do not have, creating an information asymmetry. There is no independent third-party investor advocate or representative to protect the interests of crowdfunding investors or to provide a check on the founder's decision-making authority. Investors should understand that they are relying entirely on the founder to act in their interests, and there is no guarantee that the founder will do so when conflicts arise.

As a holder of a SAFE or common stock after conversion, you will have no ability to influence or control the management or direction of Rock My Reunion, Inc. The founder and any future board of directors will have complete authority to make all decisions regarding the company's business, including decisions about operations, financing, acquisitions, sale of the company, and distributions. You will have no voting rights or ability to participate in these decisions. Additionally, as a Regulation Crowdfunding investor, you will have very limited information rights compared to investors in traditional venture capital financings or public company shareholders. The company is only required to provide annual reports and limited ongoing disclosures, which may be insufficient for you to adequately monitor your investment. The company is not subject to the same reporting requirements as public companies and is not required to provide quarterly

financial statements, hold annual meetings, or provide the level of transparency that public investors receive. You will be entirely dependent on the founder's judgment and integrity, with no meaningful ability to protect your investment or influence company decisions.
The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.
Rock My Reunion, Inc. was incorporated in May 2026 and has no operating history, no revenue, and no customers to date. We are a pre-product company with only mockups, UX flows, and engineering specifications completed. We have not yet built or launched our minimum viable product. Investors have no basis upon which to evaluate our ability to execute our business plan, achieve product-market fit, or generate revenue. Our prospects must be considered in light of the risks, expenses, and difficulties frequently encountered by companies in their early stages of development, particularly companies in competitive and evolving markets. There is no assurance that we will be successful in developing our product, attracting customers, or achieving profitability.
We are developing a platform for reunion event planning and ticketing, but we have not yet validated that there is sufficient market demand for our solution or that customers will be willing to pay for our services. Our business plan contemplates a phased rollout with specific event targets, but we have no assurance that we will achieve these milestones or that our product will gain market acceptance. The reunion planning market may be too small, too fragmented, or too seasonal to support a sustainable business. If we are unable to demonstrate product-market fit or attract a sufficient number of event organizers and attendees to our platform, our business will fail and investors will lose their entire investment.
Rock My Reunion, Inc. currently has only one full-time employee, who is the founder. Our success depends almost entirely on the continued services, skills, and efforts of this individual. The loss of our founder due to death, disability, resignation, or any other reason would have a severe adverse effect on our business and could result in the failure of the company. We do not maintain key person life insurance on our founder. Additionally, one contractor is currently working on an unpaid basis pending completion of this seed round, which creates uncertainty about whether this individual will continue to contribute to the company. Our ability to execute our business plan depends on our ability to attract, retain, and motivate additional qualified personnel, and there is no assurance we will be successful in doing so, particularly given our limited financial resources and early-stage status.
Analysis of our website reveals that the content displayed is unrelated to reunion planning services and instead shows generic entertainment profile content about Chris Rock. This mismatch between our company name, stated business purpose, and actual website content suggests potential domain configuration issues, website development delays, or other operational challenges. This discrepancy may cause confusion among potential customers, partners, and investors, and raises questions about our operational readiness and attention to critical business fundamentals. Until we establish a functional, professional web presence that accurately represents our business, we may face significant challenges in attracting customers, establishing credibility in the market, and executing our business plan.
Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.
Our business plan depends on successfully developing and launching a multi-phase technology platform over a fifteen-month period. We must build complex features including escrow ticketing systems, vendor payout mechanisms, social engagement tools, third-party integrations with services like Spotify, artificial intelligence capabilities, and a sponsor marketplace. Each phase of development carries technical risks, and we may encounter unforeseen challenges, delays, or cost overruns. We have limited financial resources and a small team, which increases the risk that we will be unable to complete development as planned. If we fail to build a functional, reliable, and user-friendly platform, or if our development timeline extends beyond our financial runway, our business will fail. Additionally, technology platforms require ongoing maintenance, updates, and security patches, which will require sustained investment and technical expertise.
Our platform will depend on various third-party technology providers, including cloud hosting services, payment processors, ticketing infrastructure, and third-party APIs such as Spotify integration. Any disruption, failure, or change in terms of service by these providers could adversely affect our operations. We have no control over the reliability, security, or continued availability of these third-party services. If a critical provider experiences downtime, increases pricing, discontinues service, or changes its API in ways that break our integrations, we may face significant operational disruptions and additional development costs. Additionally, our planned AI features will likely depend on third-party artificial intelligence services, which are rapidly evolving and subject to their own technical limitations, regulatory scrutiny, and pricing changes. Our business could be materially harmed if we are unable to maintain reliable access to these third-party technologies on commercially reasonable terms.
Rock My Reunion, Inc. has very limited cash reserves and is seeking to raise capital through this offering to fund our initial product development. Even if this offering is fully subscribed, the funds raised are only intended to support operations for approximately fifteen months. We are pre-revenue and expect to continue incurring losses for the foreseeable future. We will require substantial additional capital to continue operations beyond our initial development phases, scale our business, and achieve profitability. We have no commitments for additional funding, and there can be no assurance that financing will be available on acceptable terms, if at all. Our ability to raise additional capital may be limited by market conditions, our performance, and investor appetite for early-stage companies. If we are unable to obtain additional financing when needed, we will be forced to curtail our operations, delay or abandon our development plans, or cease operations entirely, resulting in a total loss of investment for our investors.
We are a pre-revenue company and have not generated any income to date. Our business plan contemplates significant expenses for product development, marketing, and operations before we begin generating meaningful revenue. Even after launching our platform, we may not be successful in attracting sufficient event organizers and attendees to generate revenue that exceeds our operating costs. The reunion and event planning market may not support the pricing or transaction volumes necessary for profitability. We expect to incur substantial losses for the foreseeable future, and these losses may increase as we invest in product development, customer acquisition, and scaling our operations. There is no assurance that we will ever achieve profitability or generate positive cash flow. If we are unable to achieve and sustain profitability, we will eventually exhaust our capital resources and be forced to cease operations.
The event management and ticketing industry includes numerous established competitors with significantly greater financial resources, technical capabilities, brand recognition, and customer bases than we possess. Companies such as Eventbrite, Facebook Events, and other event planning platforms already serve the reunion and social event market. These competitors have the ability to devote substantially greater resources to product development, marketing, and customer acquisition than we can. They may also offer their services at lower prices or bundle them with other popular services, making it difficult for us to compete. Additionally, larger technology companies could enter our market or expand their existing event management offerings to more directly compete with us. As a new entrant with no brand recognition, no customer base, and limited resources, we may be unable to compete effectively, gain market share, or differentiate our offering in a meaningful way. If we cannot successfully compete, our business will fail.

The Offering

USE OF FUNDS

9. What is the purpose of this offering?

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering? ⓘ

If we raise: **\$50,000**

Use of Proceeds: If only the minimum target amount is raised, expected use of proceeds is approximately 41% product development, 23% hiring and payroll, 13% sales and marketing, 15.1% working capital and general corporate purposes, 79% Wefunder fee and related offering expenses. The issuer intends to prioritize essential operating execution and near-term milestones, and management may reallocate among categories based on hiring pace, customer demand, market conditions, and timing of expenditures.

If we raise: **\$1,235,000**

Use of Proceeds: At the higher funding level, expected use of proceeds is approximately 25% product development and technology, 20% hiring and payroll, 23% sales and marketing, 24.1% working capital, operating reserves, and strategic initiatives, 7.9% Wefunder fee and related offering expenses. Additional proceeds are expected to support broader growth and reserve initiatives, and management may reallocate among categories, including in oversubscription scenarios, based on strategic priorities, business conditions, and timing of expenditures.

DELIVERY & CANCELLATIONS

11. How will the issuer complete the transaction and deliver securities to the investors?

Book Entry and Investment in the Co-Issuer. Investors will **make their investments by investing in interests issued by one or more co-issuers**, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

NOTE: Investors may cancel an investment commitment until 48 hours prior to the deadline identified in these offering materials.

The intermediary will notify investors when the target offering amount has been met. If the issuer reaches the target offering amount prior to the deadline identified in the offering materials, it may close the offering early if it provides notice about the new offering deadline at least five business days prior to such new offering deadline.

If an investor does not cancel an investment commitment before the 48-hour period prior to the offering deadline, the funds will be released to the issuer upon closing of the offering and the investor will receive securities in exchange for his or her investment.

If an investor does not reconfirm his or her investment commitment after a material change is made to the offering, the investor's investment commitment will be canceled and the committed funds will be returned.

An Investor's right to cancel. An investor may cancel his or her investment commitment at any time until 48 hours prior to the offering deadline.

If there is a material change to the terms of the offering or the information provided to the investor about the offering and/or the Company, the investor will be provided notice of the change and must re-confirm his or her investment commitment within five business days of receipt of the notice. If the investor does not reconfirm, he or she will receive notifications disclosing that the commitment was cancelled, the reason for the cancellation, and the refund amount that the investor is required to receive. If a material change occurs within five business days of the maximum number of days the offering is to remain open, the offering will be extended to allow for a period of five business days for the investor to reconfirm.

If the investor cancels his or her investment commitment during the period when cancellation is permissible, or does not reconfirm a commitment in the case of a material change to the investment, or the offering does not close, all of the investor's funds will be returned within five business days.

Within five business days of cancellation of an offering by the Company, the Company will give each investor notification of the cancellation, disclose the reason for the cancellation, identify the refund amount the investor will receive, and refund the investor's funds.

The Company's right to cancel. The Investment Agreement you will execute with us provides the Company the right to cancel for any reason before the offering deadline.

If the sum of the investment commitments from all investors does not equal or exceed the target offering amount at the time of the offering deadline, no securities will be sold in the offering, investment commitments will be cancelled and committed funds will be returned.

Ownership and Capital Structure

THE OFFERING

13. Describe the terms of the securities being offered.

To view a copy of the SAFE you will purchase, please see [Appendix B, Investor Contracts](#). The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides investors the right to **Preferred Stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Stock**, investors will receive a number of shares of **Preferred Stock** calculated using the method that results in the greater number of **Preferred Stock**:

- the total value of the investor's investment, divided by
 - the price of **Preferred Stock** issued to new investors multiplied by
 - the **discount rate** (80%), or
 - if the valuation for the company is more than **\$2,500,000.00** (the "Valuation Cap"), the amount invested by the investor divided by the quotient of
 - the Valuation Cap divided by
 - the total amount of the Company's capitalization at that time.
- For investors up to the first **\$100,000.00** of the securities, investors will receive a valuation cap of **\$1,875,000.00** and **discount rate** (80%) Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the threshold limit noted above is met.

An investor in the Company will likely hold a minority position in the Company, and thus be limited as to its ability to control or influence the governance and operations of the Company.

Overview of the Business and Financial Condition

We are an early-stage company and have incurred operating losses and negative cash flows from operations since inception. We expect to continue to incur operating losses in the near term.

As of July 12, 2026, we had cash and cash equivalents of approximately \$5,000.

Our ability to continue operations is dependent on managing our expenses and, if necessary, obtaining additional financing.

This discussion should be read in conjunction with the financial statements and related notes included in this offering statement.

Business and Operating Uncertainty

Our business operates in an environment subject to various risks, uncertainties, and changing conditions, which makes it difficult to evaluate our business, financial condition, and prospects and may limit the comparability of our results of operations from period to period.

Financial Condition

As of the date of the financial statements included in this offering statement, our total assets were \$2,500 and our current and non-current liabilities, as reflected in available financial statement fields, were \$0.

Our financial statements reflect an early-stage company with limited operating history. Investors should not place undue reliance on historical financial information given the company's limited operating history and the likelihood that future results will differ from historical results.

Liquidity and Capital Resources

As of the date of the financial statements included in this offering statement, we had cash and cash equivalents of approximately \$2,500.

Based on our current operations, we have a monthly net cash burn of approximately \$500.

Our monthly net cash burn or profit may vary significantly from month to month due to the timing of receipts and expenditures and other short-term factors. As a result, period-to-period comparisons may not be meaningful.

The Lead Investor. As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that investor to the Lead investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an individual that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such circumstances, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of investors, as discussed in section 8 above.

If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. If applicable, the Company may also be required to pay Wefunder certain fees for the preparation of tax filings. Such fees and the Company's obligation to deliver required tax documents are further specified in the related Tax Services Agreement ("TSA").

Investors should carefully review the terms of the SPV Subscription Agreement for additional information about tax filings.

Potential Dissolution of the SPV. The Company has agreed that it will pay an administrative fee and / or certain tax fees to Wefunder, in addition to delivering required tax information in the manner prescribed by the TSA, where applicable. Failure to pay such fees or provide Wefunder with required tax information could result in the dissolution of the SPV (an "SPV Dissolution Event"). Subsequent to an SPV Dissolution Event, the securities held by the SPV would be distributed directly and proportionally to the individual investors. This could create administrative complexities, as investors would need to manage the securities themselves rather than having them held and administered by the SPV. Additionally, the unplanned distribution of securities may not align with investors' intended investment strategy or asset allocation.
