In making an investment decision, investors must rely on their own examination of the issuer and the terms of the offering, including the merits and risks involved. These securities have not been recommended or approved by any federal or state securities commission or regulatory authority. Furthermore, these authorities have not passed upon the accuracy or adequacy of this document.

The U.S. Securities and Exchange Commission does not pass upon the merits of any securities offered or the terms of the offering, nor does it pass upon the accuracy or completeness of any offering document or literature.

These securities are offered under an exemption from registration; however, the U.S. Securities and Exchange Commission has not made an independent determination that these securities are exempt from registration.

Matthew Frawley and Eric Knittel are part-time officers. As such, it is likely that the company will not make the same progress as it would if that were not the case.

Our business model depends on attracting and retaining a significant number of users who choose to use our music discovery platform rather than existing alternatives. The market for music discovery is crowded with established solutions, and user behavior and preferences are difficult to predict. Users may not perceive sufficient value or differentiation in our offering to adopt our platform, particularly given the convenience of discovery features already built into major streaming services. We have not yet launched our product publicly and have no proven track record of user acquisition or retention. Even if we successfully launch our platform, there is no assurance that we will achieve meaningful user adoption or that users will engage with our platform regularly. Without substantial user adoption, we will be unable to generate revenue, attract artists and content partners, or build a sustainable business.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Rayrok Corp. was incorporated in January 2026 and is at an early stage of development with no employees and very limited cash reserves. We have a limited operating history upon which investors can evaluate our business, prospects, and likelihood of success. Our business model and product-market fit remain unproven, and we face all the risks inherent in a new enterprise in a highly competitive industry. The initial cost of completing development of our music development platform and penetrating our anticipated markets will be substantial, and there is no assurance that we will be successful in doing so. Investors should evaluate an investment in the Company with the understanding that early-stage companies face significant challenges and have a high rate of failure.

Our business model relies in part on integration with third-party music discovery platforms, particularly Spotify, to deliver music content to users. We do not own or control the music content itself, but rather provide smart links and curated discovery experiences that direct users to content on these third-party platforms. Our business is therefore dependent on maintaining technical integrations and relationships with these platforms, which may change their APIs, terms of service, business models, or policies at any time without notice. If Spotify or other streaming platforms restrict our access, change their integration requirements, increase fees, or terminate our ability to link to their content, our business model could be fundamentally undermined. We have no control over these third-party platforms and cannot guarantee continued access to their services, which creates significant business risk.

Our business depends in part on our ability to protect our proprietary technology, software code, algorithms, user interface designs, branding, and other intellectual property. We rely primarily on trade secrets, proprietary know-how, confidential information, and potentially trademark rights to protect our intellectual property. However, these protections may be inadequate, and we may not be able to prevent competitors from developing similar products or features. With no employees currently, we may face challenges in implementing appropriate confidentiality agreements and intellectual property assignment provisions with future team members and contractors. Additionally, we could face claims from third parties alleging that our platform, technology, or branding infringes their patents, copyrights, trademarks, or other intellectual property rights. The technology and music industries are characterized by extensive intellectual property portfolios held by established companies. Defending against infringement claims could be costly and distracting, and adverse outcomes could require us to pay damages, obtain licenses, modify our product, or cease certain operations, any of which could materially harm our business.

Our business plan indicates reliance on cloud hosting services, backend infrastructure, and various third-party technology platforms and services to operate our music discovery platform. We will likely depend on cloud service providers such as Amazon Web Services, Google Cloud, or similar platforms for hosting, data storage, and computing resources. We may also rely on third-party services for payment processing, analytics, content delivery, authentication, and other critical functions. Additionally, our iOS application will be distributed through Apple's App Store, making us subject to Apple's policies, review processes, and platform requirements. Any disruption, outage, security breach, or performance degradation affecting these third-party services could impair our ability to operate our platform and serve our users. Changes to pricing, terms of service, or policies by these providers could increase our costs or require significant modifications to our platform. Our dependence on these third-party services creates risks that are largely outside our control and could materially affect our operations and user experience.

Rayrok Corp. currently has very limited cash reserves and will require substantial additional capital to complete development of our platform, launch our product, acquire users, and sustain operations. The funds raised in this offering may not be sufficient to achieve our business objectives or reach profitability. We do not currently have any commitments or arrangements for additional funding beyond this offering, and there can be no assurance that additional financing will be available on acceptable terms, if at all, particularly given our early stage, lack of operating history, and the competitive nature of our market. Our ability to obtain additional financing may depend on factors outside our control, including market conditions, investor sentiment toward technology and music discovery companies, and our ability to demonstrate progress and traction. If we are unable to obtain additional capital when needed, we will be required to curtail our development and growth plans, reduce operations, or cease business entirely. The inability to obtain sufficient funding represents a material risk to our ability to execute our business plan and continue as a going concern.

Rayrok Corp. currently has no employees, which presents significant operational and execution risks. Our ability to develop our music discovery platform, execute our business plan, and achieve our objectives depends entirely on our ability to attract, hire, and retain qualified personnel with expertise in software development, music industry relationships, product management, marketing, and business operations. Competition for talented individuals in the technology and music streaming sectors is intense, particularly in markets like Austin, Texas. There can be no assurance that we will be successful in attracting and retaining the personnel we require to successfully develop and grow our business. Our failure to build an adequate team could significantly delay or prevent the development and launch of our platform and materially harm our business prospects.

Our business plan requires the successful development, testing, and launch of an iOS mobile application and supporting backend

infrastructure for our music discovery platform. Software development projects, particularly for consumer-facing applications, are complex and subject to numerous risks including technical challenges, bugs, performance issues, compatibility problems, and delays. We may encounter unforeseen technical obstacles that require significant additional time and resources to resolve. Our platform must integrate with third-party streaming services and handle music metadata, user accounts, and content delivery at scale, all of which present technical challenges. If we are unable to complete development of a functional, reliable, and user-friendly product, or if development takes significantly longer or costs more than anticipated, our business prospects will be materially harmed and we may be unable to generate revenue or achieve our business objectives.
The music industry involves complex intellectual property rights, including copyrights in musical compositions and sound recordings, performance rights, mechanical rights, and other protections. While our business model appears to involve linking to content hosted on third-party platforms rather than hosting music ourselves, we may still face legal and regulatory challenges related to how we display, organize, and present music content, album artwork, artist information, and metadata. We could face claims from record labels, music publishers, artists, photographers, or other rights holders alleging infringement or unauthorized use of their intellectual property. Additionally, we may need to comply with various music industry regulations and potentially obtain licenses or permissions for certain uses of music-related content. Defending against intellectual property claims or obtaining necessary licenses could be costly and time-consuming, and adverse outcomes could require us to pay damages, modify our platform, or cease certain operations. Our limited resources make us particularly vulnerable to the costs and disruptions of intellectual property disputes.
Rayrok Corp. has not generated any revenue to date and expects to incur operating losses for the foreseeable future as we develop our platform, build our team, acquire users, and establish our business. We will incur significant expenses related to software development, infrastructure costs, marketing and user acquisition, artist and content partner outreach, legal and compliance costs, and general operating expenses. Our business model and revenue potential remain unproven, and there is no assurance that we will be able to generate sufficient revenue to cover our expenses or achieve profitability. Even if we successfully launch our platform and attract users, we may face challenges in monetizing our user base through advertising, subscriptions, affiliate revenue, or other means. The music streaming and discovery market has proven challenging for monetization, with many companies struggling to achieve profitability despite large user bases. If we are unable to generate sufficient revenue or achieve profitability, we may be unable to continue operations and investors could lose their entire investment.
As an online platform that will collect, store, and process user data, we are subject to various data privacy and security laws and regulations, including state laws such as the California Consumer Privacy Act (CCPA), and potentially international regulations if we have users outside the United States. These laws impose requirements regarding data collection, use, storage, security, and disclosure, and grant users various rights regarding their personal information. Compliance with these regulations requires implementation of appropriate technical and organizational measures, privacy policies, user consent mechanisms, and data security practices, all of which require resources and expertise. As an early-stage company with no employees and limited resources, we may face challenges in achieving and maintaining compliance. Failure to comply with applicable data privacy laws could result in regulatory investigations, fines, penalties, legal claims, and reputational harm. Additionally, any data breach or security incident could expose us to liability, damage our reputation, and undermine user trust in our platform.
The securities being offered in this offering are Simple Agreements for Future Equity (SAFEs), which are not traditional equity or debt securities. SAFEs represent a contractual right to receive equity in the Company upon the occurrence of certain future events, such as a future priced equity financing or liquidity event. However, there is no guarantee that such triggering events will occur, and if they do not, investors may never receive equity in the Company. SAFEs have no maturity date and do not accrue interest, meaning investors have no right to demand repayment or return of their investment at any time. The terms upon which SAFEs convert into equity, including the valuation and ownership percentage investors will receive, depend on the terms of future financing rounds, which are uncertain and outside of investors' control. If the Company raises future financing at a valuation below the valuation cap, or if the Company is acquired or undergoes a liquidity event at a low valuation, investors may receive equity worth significantly less than their investment. Additionally, SAFEs are subordinate to debt and may be subordinate to other securities in liquidation scenarios. The SAFE structure creates significant uncertainty and risk for investors.
There is currently no public market for the securities being offered, and none is expected to develop in the foreseeable future. The securities have not been registered under the Securities Act of 1933 or any state securities laws and are being offered pursuant to exemptions from registration. As a result, the securities are subject to significant restrictions on transfer and may not be sold or transferred without registration or an applicable exemption. Even if the SAFEs eventually convert into equity securities, those equity securities will also be restricted and illiquid. Investors should expect to hold their investment for an indefinite period and should be prepared to bear the economic risk of their investment until the Company undergoes a liquidity event such as a sale or public offering, which may never occur. The inability to sell or transfer the securities means investors will not be able to liquidate their investment in response to changes in the Company's prospects, their personal financial circumstances, or general market conditions. This investment should be considered a long-term, illiquid investment with no certainty of return.
Investors in this offering will hold SAFEs and, if converted, will hold minority equity interests in the Company with no ability to control or materially influence Company decisions. The Company's management and any future majority shareholders will have the ability to make all decisions regarding the Company's business, strategy, financing, operations, and potential sale or liquidation. Investors will have limited information rights and will not receive the same level of financial and operational information that shareholders of public companies receive. The Company is not required to provide audited financial statements, hold annual meetings, or comply with the extensive reporting and disclosure requirements applicable to publicly traded companies. Investors will have limited visibility into the Company's performance, financial condition, and business developments, and will have limited ability to monitor their investment. This lack of control and information creates significant risks for investors who will be dependent on management's decisions and performance without the ability to influence those decisions or access comprehensive information about the Company's operations.
The music streaming and discovery market is highly competitive and dominated by large, well-established companies including Spotify, Apple Music, YouTube Music, Amazon Music, Pandora, and others. These competitors have substantially greater financial resources, larger user bases, established brand recognition, extensive music catalogs, existing relationships with record labels and artists, and significantly more experience in the industry. Many of these competitors offer music discovery features, curated playlists, and personalized recommendations as part of their core services. Additionally, social media platforms like TikTok and Instagram have become major channels for music discovery. We are attempting to enter this market as a small, early-stage company with no employees, limited resources, and an unproven product. We may not be able to compete effectively against these established competitors, and our ability to gain market share and attract users may be severely limited. If we cannot differentiate our offering and attract a sufficient user base, our business will not succeed.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides investors the right to Preferred Stock in the Company ("Preferred Stock"), when and if the Company sponsors an equity offering that involves Preferred Stock, on the standard terms offered to other investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving Preferred Stock, investors will receive a number of shares of Preferred Stock calculated using the method that results in the greater number of Preferred Stock:

- the total value of the investor's investment, divided by
- the price of Preferred Stock issued to new investors multiplied by
- the discount rate (80%), or
- if the valuation for the company is more than \$10,000,000.00 (the "Valuation Cap"), the amount invested by the investor divided by the quotient of
- the Valuation Cap divided by
- the total amount of the Company's capitalization at that time.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to investors in the SAFEs receiving Preferred Stock, investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The investor's right to receive its Cash-Out Amount is:

- Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
- On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
- Senior to payments for Common Stock.

Securities Issued by the SPV Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to accept state and federal buybacks, and receive the same disclosure, as if they had invested directly

Management's Discussion and Analysis of Financial Condition and Results of Operations

Overview of the Business and Financial Condition

The Company is building Rayrok, a music discovery platform designed to help users discover new music through short-form video previews, artist profiles, social sharing, playlists, and fan engagement features. A key part of the Company's platform is its planned listening economy, which is designed to compensate artists directly for qualified full-song listens on the platform and provide a more artist-friendly alternative to traditional streaming economics. The Company plans to generate revenue through multiple channels, including user credit purchases, subscription plans, advertising, artist-facing paid accounts, promotional placements, and future brand or entertainment partnerships.

We are an early-stage company and have incurred operating losses and negative cash flows from operations since inception. We expect to continue to incur operating losses in the near term.

As of July 13, 2026, we had cash and cash equivalents of approximately \$7,848.58.

Our ability to continue operations is dependent on managing our expenses and, if necessary, obtaining additional financing.

This discussion should be read in conjunction with the financial statements and related notes included in this offering statement.

Business and Operating Uncertainty

Our business operates in an environment subject to various risks, uncertainties, and changing conditions, which makes it difficult to evaluate our business, financial condition, and prospects and may limit the comparability of our results of operations from period to period.

Financial Condition

As of April 30, 2026, our total assets were \$6,631 and our current and non-current liabilities, as reflected in available financial statement fields, were \$6,012.

Our financial statements reflect an early-stage company with limited operating history. Investors should not place undue reliance on historical financial information given the company's limited operating history and the likelihood that future results will differ from historical results.

Liquidity and Capital Resources

As of April 30, 2026, we had cash and cash equivalents of approximately \$6,631.

Based on our current operations, we have a monthly net cash burn of approximately \$2,817.

our monthly net cash burn or profit may vary significantly from month to month due to the timing of receipts and expenditures and other short-term factors. As a result, period-to-period comparisons may not be meaningful.

Based on our current plan, we do not expect to have sufficient cash to fund operations for at least the next 12 months. The main drivers of our limited runway include:

- When customers pay us
- Whether or when we hire more people
- A one-time cost (legal, settlement, equipment, etc.)
- Timing of final Reg-D fund transfer to the company bank account, successful completion of the Regulation CF campaign, platform launch timing, app development costs, cloud infrastructure, legal/compliance costs, and marketing spend.

Our historical operations have been funded primarily through external financing.

Liquidity Assumptions

Our assessment of our liquidity and ability to fund operations is not a projection and is based on current assumptions regarding operating expenses, cash requirements, and capital needs. These assumptions may change, and actual results may differ materially due to changes in operating conditions, timing of receipts and payments, and other factors.

Dependence on Additional Financing

There can be no assurance that additional financing will be available on acceptable terms, or at all. If we are unable to raise additional capital when needed, we may be required to materially reduce or suspend operations.

Indebtedness and Capital Structure

As of the date of this offering statement, we did not have any outstanding indebtedness.

(For the avoidance of doubt, SAFEs are not treated as indebtedness.)

During the past three years, we have conducted exempt offerings, resulting in the issuance of securities in aggregate amounts of approximately \$40,000. We have also been funded with \$11,888 in capital contributions from our founder.

Known Trends, Events, and Uncertainties

Management is aware of the following trends, events, or uncertainties that are reasonably likely to have a material adverse effect on our financial condition or results of operations over the next 12 months:

Wefunder also reflects a prior \$10,000 Reg-D SAFE investment dated April 10, 2026, for total Reg-D SAFE investments of \$20,000 prior to our private round on Wefunder.

The proceeds from this offering are expected to be used to continue developing and launching our music discovery platform, including iOS app development, backend infrastructure, cloud hosting, security, product testing, artist onboarding, marketing, legal and compliance expenses, and accounting. The timing and extent of our use of proceeds will depend on the amount of proceeds raised and future operating conditions. Additional detail regarding our planned use of proceeds is provided in Item 10 of this Form C.

There can be no assurance that the proceeds of this offering will be sufficient to fund our operations or achieve our business objectives.

The Lead Investor. As described above, each investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on investors' behalf.

The Lead Investor is an individual that is chosen to act in the role of Lead investor on behalf of investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to investors before investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such circumstances, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Potential Dissolution of the SPV. The Company has agreed that it will pay an administrative fee and / or certain tax fees to Wefunder, in addition to delivering required tax information in the manner prescribed by the TSA, where applicable.
