##### Principal at Risk Securities

The Contingent Income Auto-Callable Securities with Memory due August 3 2029 based on the performance of the Common Stock of Verizon Communications Inc., which we refer to as the securities, provide an opportunity for investors to receive a coupon payment, which is an amount equal to at least \$27.875 per quarter (equivalent to at least 11.15% per annum of the stated principal amount) per security, with respect to each quarterly valuation date on which the closing price of the underlying shares is greater than or equal to 70.00% of the initial price, which we refer to as the downside threshold level. The quarterly contingent coupon payment, if any, will be payable quarterly on the relevant contingent coupon payment date. The actual coupon payment will be determined on the trade date. If the securities have not been previously redeemed, the coupon payment will be payable on the relevant coupon payment date, which is the third business day after the related determination date, except that the coupon payment date for the final determination date will be the maturity date.

If the closing price of the underlying shares is less than the coupon barrier on an observation date, the contingent coupon applicable to such observation date will not be payable to you on the relevant coupon payment date. ### Key Investment Rationale

The securities offer the opportunity for investors to receive the contingent coupon equal to at least \$27.875 per quarter (equivalent to at least 11.15% per annum of the stated principal amount) per security on each coupon payment date on which the securities are outstanding. The actual contingent coupon will be determined on the trade date. Payments on the securities will vary depending on the closing price or final price of the underlying shares on each determination date and/or the final determination date, respectively, relative to the call threshold level and the downside threshold level, as follows:

#### Scenario 1

**On any determination date other than the final determination date, the closing price is equal to or greater than the call threshold level.**

- The securities will be automatically redeemed early for an early redemption amount equal to (i) the stated principal amount plus (ii) the contingent coupon otherwise due on such date together with any previously unpaid contingent coupons with respect to any prior Observation Dates.
- Investors will not participate in any appreciation of the underlying shares from the initial price.

#### Scenario 2

**The securities are not automatically redeemed early and the final price is equal to or greater than the downside threshold level.**

- The payment due at maturity will be (i) the stated principal amount plus (ii) the contingent coupon due on Maturity Date together with any previously unpaid contingent coupons with respect to any prior Observation Dates.
- Investors will not participate in any appreciation of the underlying shares from the initial price.

#### Scenario 3

**The securities are not automatically redeemed early and the final price is less than the downside threshold level.**

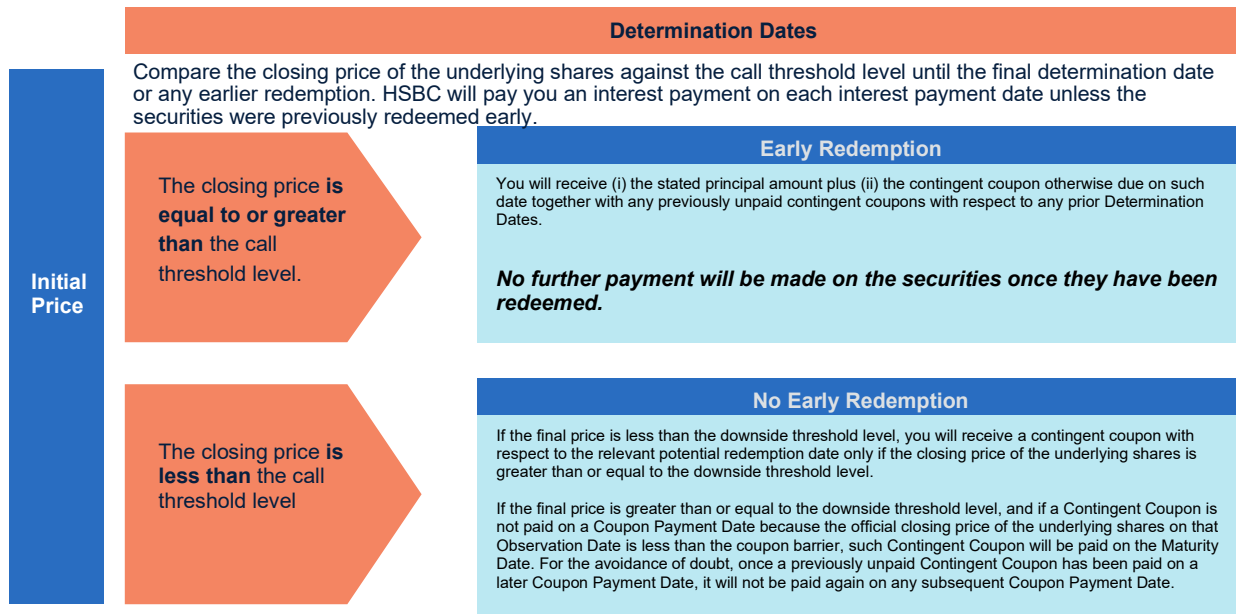

Even though the Official Closing Price of the underlying shares is below the coupon barrier on the first ten Observation Dates, since the securities are called on the eleventh Observation Date and the Official Closing Price of the underlying shares is above the initial price on the eleventh Observation Date, HSBC will pay you a total of \$1,306.625 per \$1,000 Note, reflecting your Principal Amount plus the Contingent Coupon of \$27.875 plus the ten previously unpaid Contingent Coupons of \$278.75. The total return on the securities would be 30.6625%.

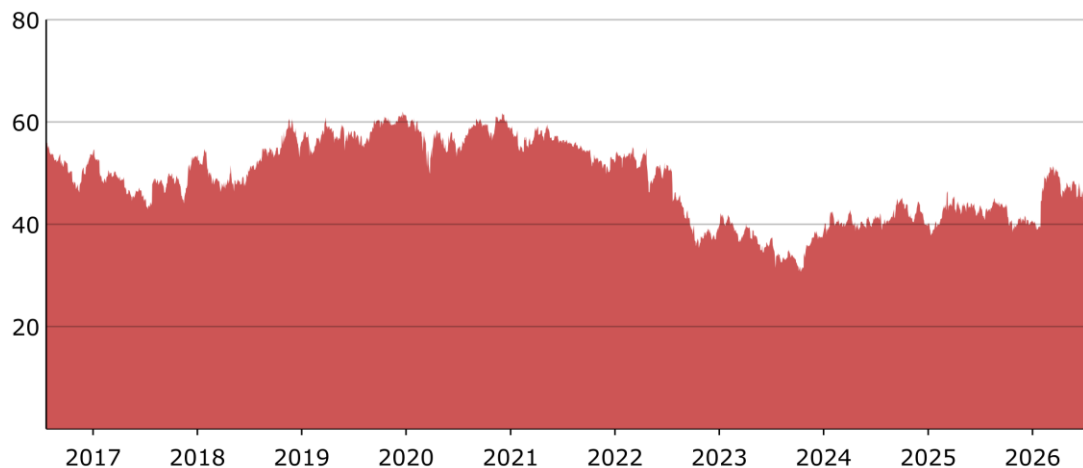

No assurance can be given that the IRS or the courts will agree with the tax treatment described herein. securities based upon the yield at which we would issue a non-contingent fixed-rate debt instrument with other terms and conditions similar to the securities. In addition, any gain such U.S. Holder might recognize upon the sale, exchange, early redemption or settlement of the securities would be ordinary income and any loss recognized by such U.S. Holder at such time would be ordinary loss to the extent of interest that same holder included in income in the current or previous taxable years in respect of the securities, and thereafter, would be capital loss.
