The U.S. Securities and Exchange Commission does not pass upon the merits of any securities offered or the terms of the offering, nor does it pass upon the accuracy or completeness of any offering document or literature.

These securities are offered under an exemption from registration; however, the U.S. Securities and Exchange Commission has not made an independent determination that these securities are exempt from registration.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Immunomatics was incorporated in March 2025 and has a very limited operating history upon which investors can evaluate our business, financial performance, and prospects. We are in the early stages of developing our AI-powered HLA compatibility modeling technology and have not yet commercialized our product or generated meaningful revenue. Our business model remains largely unproven, and we have not yet demonstrated that our technology can achieve the clinical validation, regulatory approval, market acceptance, or commercial scale necessary for success. The likelihood of our success must be considered in light of the problems, expenses, difficulties, complications, and delays frequently encountered in connection with the development of new medical technology businesses, the regulatory environment for medical AI and transplant-related products, and the competitive landscape in which we will

operate. If we are unable to successfully develop, validate, and commercialize our technology, investors may lose their entire investment.

We currently have only three employees, and our success depends heavily on the continued services and performance of this small team, particularly our founder who has domain expertise as a transplant survivor and drives our product vision. The loss of any of these key individuals could significantly impair our ability to execute our business plan, develop our technology, establish partnerships with transplant centers, navigate the regulatory approval process, and achieve our strategic objectives. Given our early stage and limited resources, we may face significant challenges in attracting, recruiting, and retaining qualified personnel with the specialized expertise required in medical AI, transplant immunology, clinical validation, and healthcare regulatory affairs. We do not maintain key person life insurance on any of our personnel. Competition for qualified employees in the healthcare technology and artificial intelligence sectors is intense, and we may not be able to attract or retain the personnel necessary to successfully develop and commercialize our products.

Our AI-powered HLA compatibility modeling technology is still in development and requires substantial clinical validation before it can be commercialized or adopted by transplant centers. We must demonstrate through rigorous clinical studies that our algorithms can accurately predict transplant outcomes, identify low-risk mismatches, and improve patient outcomes compared to existing matching approaches. This validation process is complex, time-consuming, expensive, and uncertain. We will need to secure access to extensive transplant outcomes datasets, establish partnerships with leading transplant centers for clinical studies, and demonstrate statistically significant improvements in clinically relevant endpoints. There can be no assurance that our technology will perform as expected in clinical settings, that we will be able to obtain sufficient data to validate our models, or that clinical studies will produce results that support our claims. If we are unable to successfully validate our technology or if clinical results are negative or inconclusive, we may be unable to commercialize our product, and investors could lose their entire investment.

We have limited cash reserves and have not generated meaningful revenue to date. We have incurred operating losses since our inception and expect to continue to incur significant losses for the foreseeable future as we invest in product development, clinical validation, regulatory approval processes, data acquisition, intellectual property protection, and building partnerships with transplant centers. Our ability to achieve profitability depends on numerous factors, many of which are beyond our control, including successful completion of product development, obtaining regulatory approvals, achieving market acceptance among transplant centers and clinicians, establishing favorable reimbursement arrangements, and competing effectively against established transplant matching systems. Even if we succeed in commercializing our technology, we may never achieve or sustain profitability. If we are unable to achieve and sustain profitability, investors may lose some or all of their investment.

We will require substantial additional funding beyond this offering to complete product development, conduct clinical validation studies, pursue regulatory approvals, protect our intellectual property, build partnerships with transplant centers, and commercialize our technology. We have limited cash reserves and no committed sources of additional capital. There can be no assurance that additional financing will be available on acceptable terms, or at all. Our ability to obtain additional financing will depend on numerous factors, including our progress in product development and clinical validation, market conditions, investor interest in healthcare AI companies, and the perceived prospects of our business. If we are unable to raise additional capital when needed, we may be forced to significantly curtail our product development efforts, reduce or eliminate our workforce, delay or abandon clinical validation studies, forego strategic partnerships, or cease operations entirely. Any of these outcomes would materially harm our business and could result in a total loss of investment for our investors.

We will need to raise substantial additional capital through future equity financings to fund our operations and growth. The issuance of additional equity securities, whether through priced rounds, SAFEs, convertible notes, or other instruments, will dilute the ownership percentage of existing investors, including investors in this offering. While the SAFE being offered includes a valuation cap and discount rate that provide some protection against dilution, these protections are limited and will not prevent dilution from occurring. Future investors may negotiate terms that are more favorable than those available to investors in this offering, including lower valuation caps, higher discounts, or additional rights and preferences. As we require additional capital, we may be forced to accept unfavorable terms that result in significant dilution to existing investors. There is no limit on the amount of securities we may issue in the future, and the dilutive effect of future financings could be substantial.

The organ transplant matching and compatibility assessment market includes established systems, databases, and protocols that have been used for decades, as well as other companies developing advanced matching technologies. We will compete against well-funded organizations with significantly greater resources, including established transplant networks, organ procurement organizations, large healthcare technology companies, and other AI-focused healthtech startups. Many of these competitors have longer operating histories, greater name recognition, larger customer bases, more extensive relationships with transplant centers, and substantially greater financial, technical, and marketing resources than we do. Established matching systems benefit from network effects, institutional inertia, and integration into existing clinical workflows, which may make it difficult for us to gain market acceptance even if our technology demonstrates superior performance. Competitors may develop technologies that are more effective, easier to use, less expensive, or faster to market than our solution. If we are unable to compete effectively, we may fail to gain market share, and our business and prospects would be materially harmed.

Our success depends on achieving market acceptance and adoption of our AI-powered HLA compatibility modeling technology by transplant centers, clinicians, and other stakeholders in the organ transplant ecosystem. The healthcare industry, particularly in areas as critical and established as organ transplantation, is often slow to adopt new technologies due to regulatory requirements, clinical validation standards, institutional review processes, concerns about liability, integration challenges with existing systems and workflows, and conservative decision-making cultures. Transplant centers may be reluctant to change established matching protocols or may require extensive evidence of clinical benefit before adopting our technology. Additionally, our technology's value proposition depends on clinicians trusting AI-driven recommendations in high-stakes medical decisions involving organ transplantation. Sales cycles in the healthcare sector are typically long and unpredictable, often requiring multiple years from initial contact to commercial deployment. Even if our technology demonstrates clinical benefits, we may face significant delays in achieving meaningful market penetration, which would adversely affect our revenue, growth prospects, and ability to achieve profitability.

Our ability to achieve commercial success depends in part on the extent to which reimbursement for our technology will be available from government healthcare programs, private health insurers, and other third-party payors. The healthcare reimbursement landscape is complex, varies significantly across different payors and jurisdictions, and is subject to frequent changes. There is no established reimbursement pathway for AI-powered transplant matching technologies, and we may face significant challenges in demonstrating the economic value and clinical benefits necessary to secure favorable reimbursement decisions. Payors may determine that our technology is not cost-effective, does not provide sufficient clinical benefit to justify separate reimbursement, or should be bundled into existing

is not cost effective, does not provide sufficient clinical benefit to justify separate reimbursement, or should be bundled into existing transplant procedure payments. Even if we obtain some level of reimbursement, the amounts may be insufficient to support our pricing model or may not adequately cover the costs incurred by healthcare providers in using our technology. Uncertainty regarding reimbursement may cause transplant centers to delay or decline adoption of our technology, which would materially harm our business prospects and revenue potential.

Our AI-powered HLA compatibility modeling technology is intended to assist clinicians in making organ transplant matching decisions, which likely classifies it as a medical device subject to regulation by the U.S. Food and Drug Administration (FDA). Depending on the FDA's classification of our technology, we may be required to obtain premarket clearance through the 510(k) process, premarket approval (PMA), or comply with other regulatory pathways for software as a medical device (SaMD) and AI/machine learning-based medical devices. The regulatory approval process is expensive, time-consuming, and highly uncertain, often requiring extensive clinical data, validation studies, and demonstration of safety and effectiveness. The FDA has been developing evolving guidance for AI-based medical devices, and the regulatory requirements applicable to our technology may change or become more stringent. We may experience significant delays in the approval process, receive requests for additional data or studies, or ultimately fail to obtain approval. We cannot market or commercialize our technology in the United States without the required regulatory clearances or approvals. Similar regulatory requirements exist in international markets. Any delays in obtaining regulatory approval, or failure to obtain approval, would prevent or substantially delay commercialization of our technology and could result in a complete loss of investment.

Our technology is designed to assist clinicians in making critical decisions regarding organ transplant matching, where errors or suboptimal decisions can result in organ rejection, serious patient harm, or death. Even if our technology performs as intended and receives regulatory approval, we may face product liability claims, medical malpractice claims, or other litigation if patients experience adverse outcomes following transplants where our technology was used in the matching process. Such claims could arise even if our technology was not the cause of the adverse outcome or if the technology was used improperly. Healthcare providers may be reluctant to adopt our technology due to concerns about potential liability exposure. We may not have adequate insurance coverage to protect against all potential liability claims, and product liability litigation can be extremely costly to defend regardless of merit. Any product liability claims or adverse publicity surrounding patient outcomes could severely damage our reputation, impair our ability to attract customers and partners, result in substantial financial liability, and materially harm our business prospects.

Our AI technology requires access to and processing of sensitive patient health information, including HLA typing data, transplant outcomes, and other protected health information (PHI). We are subject to stringent federal and state healthcare privacy and security regulations, including the Health Insurance Portability and Accountability Act (HIPAA), the Health Information Technology for Economic and Clinical Health (HITECH) Act, and various state privacy laws. These regulations impose significant requirements regarding the collection, use, disclosure, storage, and security of patient health information. We must implement appropriate administrative, physical, and technical safeguards to protect PHI and ensure that our business associates and partners also comply with applicable requirements. We also face increasing cybersecurity threats, and any data breach, unauthorized access, or loss of patient information could result in significant regulatory penalties, mandatory breach notifications, litigation, loss of customer trust, and reputational damage. Compliance with healthcare privacy regulations is complex and costly, and any failure to comply could result in substantial civil and criminal penalties, exclusion from government healthcare programs, and material harm to our business.

Our competitive position depends significantly on our ability to protect our proprietary AI algorithms, HLA compatibility modeling methods, software, data processing techniques, and other intellectual property. We intend to seek patent protection for our technology in the United States and key international markets, but the patent application process is expensive, time-consuming, and uncertain. We may not be able to obtain patents for our innovations, and any patents we do obtain may be challenged, invalidated, or circumvented by competitors. The scope of patent protection for AI and software-based medical technologies is evolving and uncertain, and we may face difficulties in obtaining meaningful patent coverage. We also rely on trade secrets, proprietary know-how, and confidential information to protect aspects of our technology that may not be patentable. However, trade secrets can be difficult to protect, and we may not be able to prevent unauthorized disclosure or use of our confidential information. Additionally, we may face claims that our technology infringes on the intellectual property rights of others, which could result in costly litigation, licensing obligations, or restrictions on our ability to commercialize our technology. Any failure to adequately protect our intellectual property or any infringement claims against us could materially harm our competitive position and business prospects.

Investors in this offering will receive a Simple Agreement for Future Equity (SAFE), which is not a debt instrument and does not have a maturity date or require the company to repay the investment amount. The SAFE will convert into equity only upon the occurrence of specific triggering events, such as a future priced equity financing, a liquidity event, or dissolution of the company. There is no guarantee that any of these conversion events will occur, and if they do not, investors may never receive equity in the company or any return on their investment. The valuation at which the SAFE converts into equity will depend on the terms of future financing rounds and other factors beyond investors' control. Even with the valuation cap and discount rate included in this SAFE, investors may receive fewer shares than anticipated or shares that represent a smaller ownership percentage than expected. If the company is dissolved without a conversion event occurring, SAFE holders have only a limited right to receive proceeds after creditors and other priority claims are satisfied, and there may be no proceeds available for distribution to SAFE holders. The uncertain nature of the SAFE conversion means investors face significant uncertainty regarding if, when, and on what terms they will receive equity in the company.

An investment in this offering is highly speculative and involves a high degree of risk, including the possibility of a complete loss of your investment. The securities being offered have not been registered under the Securities Act of 1933 or any state securities laws and are being offered in reliance on exemptions from registration requirements. As a result, the securities are subject to significant restrictions on transfer and may not be sold or transferred except in compliance with applicable securities laws, which generally require either registration or an available exemption. There is no public market for these securities, and we do not expect one to develop. Even after the securities convert into equity, there will likely be no market for the resulting shares. Investors must be prepared to hold their investment for an indefinite period and should not invest unless they can afford to lose their entire investment. Under Regulation Crowdfunding, investors are subject to a one-year holding period during which the securities cannot be transferred except in very limited circumstances. The illiquid nature of this investment means that investors will not be able to access their capital or respond to changes in the company's performance or market conditions.

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. Use of Proceeds: If only the minimum target amount is raised, Immunomatics expects to use proceeds approximately as follows: 63% AI Algorithm Development and Proof of Concept, 18% Transplant Outcomes Data Acquisition, 11.1% Clinical and Regulatory Advisory Support, and 7.9% Wefunder fee and related offering expenses. Management intends to allocate proceeds as described but may adjust priorities based on clinical feedback, data availability, and other factors outside the company's control.

If we raise: **\$500,000**

Use of Proceeds: If the maximum offering amount is raised, including any oversubscriptions, Immunomatics expects to use proceeds approximately as follows: 36% AI Algorithm Development and Validation, 18% Transplant Center Partnerships and Data, 16% Domestic and International IP Protection, 11% Clinical and Regulatory Advisory Support, 11.1% Early Commercial and Market Development, and 7.9% Wefunder fee and related offering expenses. Management expects to apply oversubscription proceeds toward expanded validation and market development activities but may reallocate among categories as operational needs and opportunities evolve.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

22. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

An Investor in the Company will likely hold a minority position in the Company, and thus be limited as to its ability to control or influence the governance and operations of the Company.

The marketability and value of the Investor's interest in the Company will depend upon many factors outside the control of the Investor. The Company will be managed by its officers and be governed in accordance with the strategic direction and decision-making of its Board Of Directors, and the Investor will have no independent right to name or remove an officer or member of the Board Of Directors of the

Management's Discussion and Analysis of Financial Condition and Results of Operations

Overview of the Business and Financial Condition

Immunomatics, Inc. is a biotechnology software company developing an artificial intelligence-based platform intended to support transplant teams in assessing donor-recipient compatibility prior to transplantation, initially focusing on organ and blood stem cell transplants. The Company is currently in the proof-of-concept and clinical validation stage and has not yet commenced commercial operations. Upon successful validation, the Company intends to commercialize its platform through institutional software agreements with transplant centers, laboratories, and donor registries, with a business model based on recurring enterprise software fees.

We are an early-stage company and have incurred operating losses and negative cash flows from operations since inception. We expect to continue to incur operating losses in the near term.

As of July 14, 2026, we had cash and cash equivalents of approximately \$26,795.90.

Our ability to continue operations is dependent on managing our expenses and, if necessary, obtaining additional financing.

This discussion should be read in conjunction with the financial statements and related notes included in this offering statement.

Business and Operating Uncertainty

Our business operates in an environment subject to various risks, uncertainties, and changing conditions, which makes it difficult to evaluate our business, financial condition, and prospects and may limit the comparability of our results of operations from period to period.

Financial Condition

As of the date of the financial statements included in this offering statement, our total assets were \$72,210 and our current and non-current liabilities, as reflected in available financial statement fields, were \$140,209.

Our financial statements reflect an early-stage company with limited operating history. Investors should not place undue reliance on historical financial information given the company's limited operating history and the likelihood that future results will differ from historical results.

Liquidity and Capital Resources

As of the date of the financial statements included in this offering statement, we had cash and cash equivalents of approximately \$56,954.

Based on our current operations, we have a monthly net cash burn of approximately \$4,240.

Our monthly net cash burn or profit may vary significantly from month to month due to the timing of receipts and expenditures and other short-term factors. As a result, period-to-period comparisons may not be meaningful.

Based on our current plan, we do not expect to have sufficient cash to fund operations for at least the next 12 months. We may run out of cash in the next 12 months if we raise less than \$200,000.

Our historical operations have been funded primarily through external financing.

Liquidity Assumptions

Our assessment of our liquidity and ability to fund operations is not a projection and is based on current assumptions regarding operating expenses, cash requirements, and capital needs. These assumptions may change, and actual results may differ materially due to changes in operating conditions, timing of receipts and payments, and other factors.

Dependence on Additional Financing

There can be no assurance that additional financing will be available on acceptable terms, or at all. If we are unable to raise additional capital when needed, we may be required to materially reduce or suspend operations.

Indebtedness and Capital Structure

As of the date of this offering statement, we had total outstanding indebtedness consisting of 1 loan and approximately \$30,000 in aggregate principal obligations. The material terms of such indebtedness are described in Item 24 of this Form C.

(For the avoidance of doubt, SAFEs are not treated as indebtedness.)

During the past three years, we have conducted exempt offerings, resulting in the issuance of securities in aggregate amounts of approximately \$120,000.

The Lead Investor. As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that Investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an individual that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement.
