6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

Company Overview and History:

Founding & Early Innovation (2013–2015)

xCraft Enterprises was founded in 2013 in Sandpoint, Idaho, by JD Claridge — an entrepreneur with a background spanning multiple successful aerospace companies — alongside co-founder Charles Manning, founder and CEO of Kochava, a leading mobile attribution analytics platform serving tier-one global advertisers.

The company's earliest work centered on the **X PlusOne**, a hybrid UAV capable of both hovering like a multirotor and transitioning to fixed-wing flight at speeds of up to 60 mph and altitudes of up to 10,000 feet. This design represented a fundamental rethinking of what a consumer and commercial drone could be — combining the convenience of vertical takeoff and landing (VTOL) with the range and speed of a fixed-wing aircraft.

Initial prototypes were assembled by hand in JD Claridge's garage, and early iterations were supported through a successful Kickstarter campaign that garnered national attention in the burgeoning drone community.

National Recognition: ABC's Shark Tank (2015)

In November 2015, xCraft appeared on **ABC's Shark Tank Season 7, Episode 5**. JD Claridge and Charles Manning pitched the X PlusOne drone to the panel of celebrity investors, demonstrating its unique hybrid flight capabilities live on stage. The pitch was historic — xCraft received offers from **all five Sharks**, including Kevin O'Leary, Mark Cuban, Lori Greiner, Robert Herjavec, and Daymond John. The company ultimately secured a **\$1.5 million investment**, making it one of the most successful pitches in the show's history at that time.

The Shark Tank appearance gave xCraft significant national media coverage, with the company subsequently featured in VentureBeat, TechCrunch, Fortune, Inc.com, Business Insider, Fast Company, MarketWatch, and UAS Magazine, among others.

Strategic Pivot to Enterprise & Defense (2016–2022)

Following its Shark Tank success, xCraft executed a deliberate strategic pivot away from the consumer drone market — which had become increasingly dominated by low-cost Chinese manufacturers, particularly DJI — and refocused its efforts on high-value enterprise, defense, and government applications.

This pivot proved prescient. By focusing on mission-critical applications in public safety, surveying and mapping, defense, and mining and construction, xCraft was able to command higher price points, build longer-term customer relationships, and develop proprietary technologies that differentiated its products from commodity consumer drones.

During this period, the company completed additional equity crowdfunding campaigns — including a raise on StartEngine in 2022 that exceeded \$130,000 — and continued developing its product portfolio, resulting in the Panadrone tethered drone system, the Matrix RTK surveying platform, the SHADOW persistent surveillance drone, and the Nano One thermal imaging platform.

Recent Developments & Market Opportunity (2023–2026)

The regulatory and geopolitical environment shifted dramatically in 2024 and 2025 in ways that have created a significant tailwind for American drone manufacturers like xCraft. In December 2024, President Biden signed the National Defense Authorization Act for Fiscal Year 2025, which included provisions requiring a national security review of DJI and other Chinese drone manufacturers. In October 2024, U.S. Customs and Border Protection began detaining DJI shipments at the border, citing forced labor laws. In June 2025, President Trump signed executive orders to boost the U.S. drone industry and increase protections against foreign-made drones.

These developments have created an estimated \$5 billion domestic market opportunity as DJI drones are effectively removed from major retail and enterprise channels. xCraft has moved to capture this opportunity: in 2025, the company landed a \$1 million purchase order from Best Buy, representing a potential re-entry into the consumer space and a major validation of the company's commercial viability.

As of 2026, xCraft continues to operate and innovate from its Idaho headquarters, with a team of experienced engineers, operators, and business development professionals. The company has conducted conversations with the Department of Defense regarding drone deployments, has delivered UAVs to the U.S. Air Force Academy for UAS training, and is actively engaged in discussions with defense and government procurement officials.

Market Opportunity:

xCraft operates at the intersection of several high-growth market segments within the global UAV industry. The following market size estimates reflect the scale of opportunity the company is positioned to address:

- Global Urban Air Mobility (UAM) Market: Projected to reach \$86.83 billion by 2035
- Commercial Drone Market: Projected to reach \$35.4 billion by 2026
- Military/Defense Drone Market: Projected to reach \$21.76 billion by 2026
- U.S. Consumer/Enterprise Drone Market Displacement from DJI: Estimated at \$5+ billion

Beyond the aggregate market size, xCraft benefits from several structural tailwinds that are uniquely favorable to American drone manufacturers:

- National security legislation requiring review and potential ban of Chinese drone manufacturers (NDAA FY2025)
- Executive branch policy prioritizing American-made drone procurement for government and defense contracts
- Growing demand for persistent aerial surveillance in law enforcement, border security, and emergency response
- Accelerating adoption of drone-based data collection in agriculture, mining, and construction
- Expanding defense budgets and increased interest in low-cost, high-capability unmanned systems

Business Model:

xCraft operates a B2B-focused business model, selling its drone platforms and associated services primarily to enterprise customers, government agencies, and defense contractors. The company does not currently sell directly to retail consumers, having made a strategic decision to focus on higher-value commercial relationships.

Revenue is generated through four primary channels:

- Direct hardware sales of drone platforms and accessories to enterprise and government customers
- Service and maintenance contracts for deployed drone systems

- Custom engineering and integration work for defense and government customers with specialized requirements
- Strategic partnerships and co-development arrangements, including with T-Mobile for Business

The company serves four primary vertical markets: Public Safety (law enforcement, fire, search and rescue), Defense (military, government, intelligence), Surveying & Mapping (geospatial, engineering, construction), and Mining & Construction (site management, volumetric analysis, inspection).

Competitive Landscape:

The global UAV market is highly competitive, with participants ranging from large defense contractors to consumer electronics companies to specialized commercial drone manufacturers. xCraft's primary competitive differentiation is built on three pillars:

- **American Manufacturing:** All xCraft products are designed and manufactured in the United States, which is increasingly a legal and procurement requirement for government and defense customers, and a growing preference for enterprise buyers concerned about data security and supply chain integrity.
- **Patented Technology:** xCraft holds proprietary patents covering its core UAV innovations, providing legal protection for its designs and creating competitive barriers to imitation by both domestic and foreign competitors.
- **Mission-Specific Engineering:** Unlike consumer drone manufacturers that build general-purpose platforms, xCraft designs its products around the specific operational requirements of its target markets — enabling superior performance in demanding real-world conditions.

The displacement of DJI and other Chinese drone manufacturers from U.S. government, defense, and enterprise markets creates a structural opportunity for xCraft that is unlikely to reverse in the near to medium term given current geopolitical dynamics and legislative momentum.

Strategic Partnerships:

T-Mobile for Business

xCraft is a registered partner of T-Mobile for Business, integrating T-Mobile's nationwide 5G network into next-generation drone platforms. This partnership enables xCraft drones to leverage real-time 5G connectivity for beyond-visual-line-of-sight (BVLOS) operations, ultra-low-latency

video streaming, and seamless fleet management — capabilities critical for enterprise and defense deployments where reliable, low-latency communications are essential.

Defense & Government Relationships

xCraft has established relationships with multiple branches of the U.S. military and government agencies. The company has delivered drone systems to the U.S. Air Force Academy for UAS training programs and has engaged in procurement discussions with the Department of Defense. These relationships represent a significant long-term growth opportunity as defense budgets for unmanned systems continue to expand.

Best Buy Partnership

In 2025, xCraft secured a \$1 million purchase order from Best Buy, representing an important re-entry point into the retail distribution channel as DJI drones face increasing regulatory headwinds in the U.S. market. This relationship positions xCraft to potentially capture a meaningful share of the consumer and prosumer drone market that DJI has vacated.

Risk Factors

Investing in the Securities involves a high degree of risk and may result in the loss of your entire investment. Before making an investment decision with respect to the Securities, we urge you to carefully consider the risks described in this section and other factors set forth in this Form C. In addition to the risks specified below, the Company is subject to same risks that all companies in its business, and all companies in the economy, are exposed to. These include risks relating to economic downturns, political and economic events and technological developments (such as hacking and the ability to prevent hacking). Additionally, early-stage companies are inherently riskier than more developed companies. Prospective Investors should consult with their legal, tax and financial advisors prior to making an investment in the Securities. Risks Related to the Company's Business and Industry

We have a limited operating history upon which you can evaluate our performance, and accordingly, our prospects must be considered in light of the risks that any new company encounters. The Company is still in an early phase and we are just beginning to implement our business plan. There can be no assurance that we will ever operate profitably. The likelihood of our success should be considered in light of the problems, expenses, difficulties, complications and delays usually encountered by early-stage companies. The Company may not be successful in attaining the objectives necessary for it to overcome these risks and uncertainties.

Global crises such as COVID-19 can have a significant effect on our business operations and revenue projections.

There is an ongoing outbreak of a novel and highly contagious form of coronavirus ("COVID-19"), which the World Health Organization declared a global pandemic on March 11, 2020. The outbreak of COVID-19 has caused a worldwide public health emergency with a substantial number of hospitalizations and deaths and has significantly adversely impacted global commercial activity and contributed to both volatility and material declines in equity and debt markets. The global impact of the outbreak is rapidly evolving, and many national, state, and local governments have reacted by instituting mandatory or voluntary quarantines, travel prohibitions and restrictions, closures or reductions of offices, businesses, schools, retail stores, restaurants, and other public venues and/or cancellations, suspensions and/or postponements of certain events and activities, including certain non-essential government and regulatory activities. Businesses are also implementing their own precautionary measures, such as voluntary closures, temporary or permanent reductions in work force, remote working arrangements and emergency contingency plans.

Such measures, as well as the general uncertainty surrounding the dangers, duration, and impact of COVID-19, are creating significant disruption to supply chains and economic activity, impacting consumer confidence and contributing to significant market losses, including by having particularly adverse impacts on transportation, hospitality, healthcare, tourism, sports,

entertainment and other industries dependent upon physical presence. Technological infrastructure has, and will likely continue to be, strained for so long as mandatory or voluntary quarantines are instituted, which will change, and potentially disrupt, the operations of the Company. As COVID-19 continues to spread, potential additional adverse impacts, including a global, regional or other economic recession of indeterminate duration, are increasingly likely and difficult to assess and, if the spread of COVID-19 is prolonged, it could adversely affect many economies, global financial markets and the Company even after COVID- 19 is contained.

The extent of the impact of COVID-19 on the Company's operational and financial performance will depend on many factors, all of which are highly uncertain and cannot be predicted. Those factors include the duration and scope of the resulting public health emergency; the extent of any related restrictions implemented; the impact of such public health emergency on overall supply and demand, goods and services, investor liquidity, consumer confidence and levels of economic activity; and the extent of its disruption to important global, regional and local supply chains and economic markets. The effects of the COVID-19 pandemic may materially and adversely impact the value, performance and liquidity of the Company.

In addition, COVID-19 and the resulting changes to global businesses and economies likely will adversely impact the business and operations of the Company and therefore the business and operations of the Company. Certain businesses and activities may be temporarily or permanently halted as a result of government or other quarantine measures, voluntary and precautionary restrictions on travel or meetings and other factors, including the potential adverse impact of COVID-19 on the health of key personnel.

The amount of capital the Company is attempting to raise in this Offering may not be enough to sustain the Company's current business plan.

In order to achieve the Company's near and long-term goals, the Company may need to procure funds in addition to the amount raised in the Offering. We may face potential difficulties in obtaining capital

In particular, we are dependent on our managers. The loss of the Managers, the Principals or any other key personnel could harm the Company's business, financial condition, cash flow and performance. Accordingly, you should not invest in the Company unless you are willing to

entrust all aspects of the management of the Company and the investment decisions we make on the behalf of the Company.

Although dependent on certain key personnel, the Company does not have any key person life insurance policies on any such people

We are dependent on certain key personnel in order to conduct our operations and execute our business plan, however, the Company has not purchased any insurance policies with respect to those individuals in the event of their death or disability. Therefore, if any of these personnel die or become disabled, the Company will not receive any compensation to assist with such person's absence. The loss of such person could negatively affect the Company and our operations. We have no way to guarantee key personnel will stay with the Company, as many states do not enforce non-competition agreements, and therefore acquiring key man insurance will not ameliorate all of the risk of relying on key personnel.

Damage to our reputation could negatively impact our business, financial condition and results of operations.

Our reputation and the quality of our brand are critical to our business and success and will be critical to our success as we form and advise new markets. Any incident that erodes confidence in our brand could significantly reduce the Company's value and damage our business. We may be adversely affected by any negative publicity, regardless of its accuracy. Also, there has been a marked increase in the use of social media platforms and similar devices, including blogs, social media websites and other forms of internet-based communications that provide individuals with access to a broad audience. The availability of information on social media platforms is virtually immediate as is its impact. Information posted may be adverse to our interests or may be inaccurate, each of which may harm our performance, prospects or business. The harm may be immediate and may disseminate rapidly and broadly, without affording us an opportunity for redress or correct.

Risks Related to the Offering

The U.S. Securities and exchange Commission does not pass upon the merits of the Securities or the terms of the Offering, nor does it pass upon the accuracy or completeness of any Offering document or literature.

You should not rely on the fact that our Form C is accessible through the U.S. Securities and Exchange Commission's EDGAR filing system as an approval, endorsement or guarantee of compliance as it relates to this Offering. The U.S. Securities and Exchange Commission has not reviewed this Form C, nor any document or literature related to this Offering.

Neither the Offering nor the Securities have been registered under federal or state securities laws.

No governmental agency has reviewed or passed upon this Offering or the Securities. Neither the Offering nor the Securities have been registered under federal or state securities laws. Investors will not receive any of the benefits available in registered Offerings, which may include access to quarterly and annual financial statements that have been audited by an independent accounting firm. Investors must therefore assess the adequacy of disclosure and the fairness of the terms of this Offering based on the information provided in this Form C and the accompanying exhibits.

The Company's management may have broad discretion in how the Company uses the net proceeds of the Offering.

Unless the Company has agreed to a specific use of the proceeds from the Offering, the Company's management will have considerable discretion over the use of proceeds from the Offering. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

The Company has the right to limit individual Investor commitment amounts based on the Company's determination of an Investor's sophistication.

This increase in number of shares outstanding could result from a stock offering (such as an initial public offering, another crowdfunding round, a venture capital round, angel investment), employees exercising stock options, or by conversion of certain instruments (e.g., convertible bonds, preferred shares or warrants) into stock. If the company decides to issue more shares, an investor could experience value dilution, with each share being worth less than before, and control dilution, with the total percentage an investor owns being less than before. There may also be earnings dilution, with a reduction in the amount earned per share (though this typically occurs only if the company offers dividends, and most early-stage companies are unlikely to offer dividends, preferring to invest any earnings into the company).

18. Are there any differences not reflected above between the securities being offered and each other class of security of the issuer?

As a minority holder of Class B Non-Voting Common Stock of the company, you will have no voting rights in regard to the corporate actions of the company, including additional issuances of securities, company repurchases of securities, a sale of the company or its significant assets, or company transactions with related parties. Further, investors in this offering may have rights less than those of other investors and will have limited influence on the corporate actions of the company.

19. How could the exercise of rights held by the principal owners identified in Question 5 above affect the purchasers of Securities being offered?

The holder of a majority of the voting rights in the company may make decisions with which you disagree, or that negatively affect the value of your investment in the company, and you will have no recourse to change those decisions. Your interests may conflict with the interests of other investors, and there is no guarantee that the company will develop in a way that is advantageous to you. For example, the majority shareholder may decide to issue additional shares to new investors, sell convertible debt instruments with beneficial conversion features, or make decisions that affect the tax treatment of the company in ways that may be unfavorable to you. Based on the risks described above, you may lose all or part of your investment in the securities that you purchase, and you may never see positive returns.

The issuer is raising this Regulation Crowdfunding round at a \$57,499,854.92 pre-money valuation, excluding options and warrants.

The securities being offered are valued at the issuer's discretion. The Company has released multiple new products, eliminating most debt, launching a concerted B2B sales strategy, and breaking ground in the design of eVTOL technology. The Company is even better positioned to take advantage of the potential in the Urban Air Mobility Market as well as capitalize on their new “bread and butter” drone division. The US drone Market has increased with new opportunities due to procurement restrictions put on Chinese companies due to security vulnerabilities. The market share of the largest Chinese companies dropped from 74% in 2018 to 54% in 2021 (Source: Bloomberg). The market is growing and DJI’s drop is opening up more potential. This opens yet another door for “America’s Drone Company” to capture significant market share. For example, even if xCraft is only able to capture 3% of DJI’s loss in 2022, there is a \$60M potential.

The Company has set its valuation internally without a formal-third party independent evaluation. The pre-money valuation has been calculated on a fully diluted basis. In making this calculation, we have assumed all outstanding options and warrants are exercised.

An early-stage company typically sells its shares (or grants options over its shares) to its founders and early employees at a very low cash cost, because they are, in effect, putting their "sweat equity" into the company. When the company seeks cash investments from outside investors, like you, the new investors typically pay a much larger sum for their shares than the founders or earlier investors, which means that the cash value of your stake is immediately diluted because each share of the same type is worth the same amount, and you paid more for your shares than earlier investors did for theirs.

There are several ways to value a company, and none of them is perfect and all of them involve a certain degree of guesswork. Any of these methods, plus others, may be used to determine valuation in the future:

Liquidation Value - The amount for which the assets of the company can be sold, minus the liabilities owed, e.g., the assets of a bakery include the cake mixers, ingredients, baking tins, etc. The liabilities of a bakery include the cost of rent or mortgage on the bakery. However, this value does not reflect the potential value of a business, e.g., the value of the secret recipe. The value for most startups lies in their potential, as many early-stage companies do not have many assets.

Book Value - This is based on analysis of the company's financial statements, usually looking at the company's balance sheet as prepared by its accountants. However, the balance sheet only looks at costs (i.e., what was paid for the asset), and does not consider whether the asset has increased in value over time. In addition, some intangible assets, such as patents, trademarks or trade names, are very valuable but are not usually represented at their market value on the balance sheet.

Earnings Approach - This is based on what the investor will pay (the present value) for what the investor expects to obtain in the future (the future return), taking into account inflation, the lost opportunity to participate in other investments, the risk of not receiving the return. However, predictions of the future are uncertain and valuation of future returns is a best guess.

Different methods of valuation produce a different answer as to what your investment is worth. Typically, liquidation value and book value will produce a lower valuation than the earnings approach. However, the earnings approach is also most likely to be risky as it is based on many assumptions about the future, while liquidation value and book value are much more conservative.

Future investors (including people seeking to acquire the company) may value the company differently. They may use a different valuation method, or different assumptions about the company's business and its market. Different valuations may mean that the value assigned to your investment changes. It frequently happens that when a large institutional investor such as a venture capitalist makes an investment in a company, it values the company at a lower price than the initial investors did. If this happens, the value of the investment would go down.

21. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

The company's Certificate of Incorporation or Bylaws can be amended by the holders of a majority of the issued and outstanding shares of the Company. As minority owners, the crowdfunding investors are subject to the decisions made by the majority owners. The issued and outstanding shares of common stock give management voting control of the company. As a minority owner, you may be outvoted on issues that impact your investment, such as, among other things: (a) the liquidation, dissolution or winding up of the company, or effecting any merger or consolidation; (b) amendment of any provision of the Certificate of Incorporation or Bylaws; (c) creation and issuance of other securities having rights, preferences or privileges senior to the common stock sold to the crowdfunding investors, or increasing the authorized number of shares of stock of the company; or (d) creation of any debt security.

The authorization and issuance of additional shares of the company's common stock will dilute the ownership of the crowdfunding investors. As a result, if the company achieves profitable operations in the future, its net income per share will be reduced because of dilution, and the market price of the company's common stock, if there is a market price, could decline as a result of the additional issuances of securities. If the company repurchases securities, so that the above risk is mitigated, and there are fewer shares of common stock outstanding, the company may not have enough cash available for marketing expenses, growth, or operating expenses to reach our

goals. If we do not have enough cash to operate and grow, we anticipate the market price of our securities would decline. A sale of the company or of all of the assets of the company may result in an entire loss of your investment. We cannot predict the market value of the company or its assets, and the proceeds of a sale may not be cash, but instead, unmarketable securities, or an assumption of liabilities. It is unlikely that in the near term, a sale would result in a premium that is significant enough over book value to generate a return to our investors. We may need to negotiate with a related party for additional capital. No assurance can be given that such funds will be available or, if available, will be on commercially reasonable terms satisfactory to us. Even if such financing is available, it may be on terms that are materially adverse to your interests with respect to dilution of book value, dividend preferences, liquidation preferences, or other terms.

Financial Condition of the Issuer

For the year ended December 31, 2025, xCraft Enterprises, Inc. reported revenue of \$178,008, compared to \$504,452 in 2024. Gross profit was \$144,473, compared to \$489,416 in 2024, while operating expenses totaled \$257,727, resulting in an operating loss of \$113,255.

The Company reported net income of \$245,483 in 2025, compared to a net loss of \$50,958 in 2024. The 2025 net income was substantially attributable to a \$575,532 non-cash gain from the settlement of liabilities, rather than operating profitability.

As of December 31, 2025, the Company had total assets of \$91,198 and total liabilities of \$872,377, resulting in a stockholders' deficit of \$781,179. Current assets totaled \$35,833 compared to current liabilities of \$644,668. The Company also had a negative bank balance of approximately \$3,875 at year-end.

The Company generated negative cash flow from operating activities of approximately \$98,665 during 2025 and ended the year with a negative cash balance. The financial statements state that these conditions raise substantial doubt about the Company's ability to continue as a going concern. Management is pursuing operational improvements, cost reductions, and additional financing to support ongoing operations.
