In making an investment decision, investors must rely on their own examination of the issuer and the terms of the offering, including the merits and risks involved. These securities have not been recommended or approved by any federal or state securities commission or regulatory authority. Furthermore, these authorities have not passed upon the accuracy or adequacy of this document.

The U.S. Securities and Exchange Commission does not pass upon the merits of any securities offered or the terms of the offering, nor does it pass upon the accuracy or completeness of any offering document or literature.

These securities are offered under an exemption from registration; however, the U.S. Securities and Exchange Commission has not made an independent determination that these securities are exempt from registration.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Metroair, Inc. was incorporated in May 2025 and has a very limited operating history upon which investors can evaluate our business, financial performance, and prospects. We are an early-stage company with only three employees and limited operational infrastructure. Our business model remains largely unproven, and we have not yet demonstrated our ability to successfully manufacture, market, and sell our products at scale. The lack of historical financial data and operational track record makes it difficult to predict our future performance or assess the viability of our business plan. Investors should be aware that early-stage companies face substantially higher risks of failure than more established businesses, and there is no assurance that we will be able to successfully execute our business strategy or achieve profitability.

There is no public market for the SAFE securities being offered, and we do not expect one to develop. The securities have not been registered under the Securities Act of 1933 or any state securities laws, and they are subject to significant restrictions on transfer. Investors will be required to hold these securities for an indefinite period and should be prepared to bear the financial risks of this investment for the long term. Even if the SAFEs eventually convert into equity securities, those equity securities will also be restricted and illiquid. We have no plans to register any securities for resale, conduct an initial public offering, or facilitate a secondary market for our securities. The lack of liquidity means that investors will likely be unable to sell their securities even in the event of an emergency or change in financial circumstances. Investors should not invest in this offering unless they can afford to hold the investment indefinitely.

Our success depends heavily on the continued services and performance of our small team of three employees. The loss of any key personnel could have a material adverse effect on our business operations, product development, and growth prospects. With such a limited team, we lack redundancy in critical functions, and the departure of even one team member could significantly disrupt our operations. We face intense competition for qualified personnel in the manufacturing and engineering sectors, and we may not be able to attract, retain, or motivate the additional employees we need to execute our business plan. We do not maintain key person life insurance on any of our team members. If we are unable to retain our current personnel or hire additional qualified individuals, our ability to develop our products, scale our manufacturing operations, and grow our business will be materially impaired.

Our business plan relies on our ability to successfully scale manufacturing operations through investment in 3D printing equipment and factory infrastructure. Manufacturing using 3D printing technology presents unique technical, operational, and quality control challenges that we may not be able to overcome. We have limited experience operating at scale, and there is no assurance that our manufacturing processes will be cost-effective, reliable, or capable of producing products that meet market quality standards. Equipment failures, technical difficulties, supply chain disruptions for materials and components, or quality control issues could result in production delays, increased costs, or defective products. Our inability to successfully scale our manufacturing capabilities would prevent us from fulfilling customer orders, generating revenue, and achieving our business objectives.

Our business plan includes aggressive expansion of our engineering team across hardware, software, and quality assurance disciplines. However, we face significant challenges in recruiting and retaining qualified engineers in a highly competitive labor market. Specialized engineering talent, particularly in hardware development and advanced manufacturing, is in high demand and commands substantial compensation packages that may exceed our financial resources. As an early-stage company with limited cash reserves and an uncertain future, we may be unable to offer competitive salaries, benefits, or equity incentives necessary to attract top talent. Delays in hiring or our inability to recruit engineers with the required expertise could significantly slow our product development roadmap, delay our path to mass production, and prevent us from achieving our business milestones.

We currently have limited cash reserves and will require substantial additional capital to execute our business plan, scale our manufacturing operations, expand our engineering team, and achieve profitability. The funds raised in this offering will not be sufficient to fully fund our operations or achieve our long-term business objectives. We do not have any commitments or arrangements for additional financing, and there can be no assurance that we will be able to raise additional capital on acceptable terms, or at all. Our ability to obtain additional financing will depend on numerous factors, including market conditions, investor sentiment, our operating performance, and the progress of our product development. If we are unable to secure additional funding when needed, we may be forced to delay, reduce, or eliminate our product development efforts, scale back our manufacturing expansion plans, reduce headcount, or cease operations entirely.

We are not currently profitable and have incurred losses since our inception. We expect to continue incurring significant losses for the foreseeable future as we invest in manufacturing equipment, expand our engineering team, develop our products, and build our operational infrastructure. Our losses are likely to increase substantially as we scale our operations and pursue our growth strategy. There is no assurance that we will ever achieve profitability or generate positive cash flow from operations. Our ability to achieve

profitability will depend on numerous factors, many of which are beyond our control, including our ability to successfully manufacture and sell products, achieve market acceptance, control costs, and compete effectively. If we are unable to achieve and sustain profitability, investors may lose some or all of their investment.	We operate in a competitive manufacturing industry where we face competition from established companies with significantly greater financial resources, technical expertise, manufacturing capacity, brand recognition, and customer relationships. Many of our competitors have longer operating histories, larger customer bases, more established supply chains, and greater ability to withstand economic downturns or industry disruptions. These competitors may be able to respond more quickly to market changes, adopt new technologies faster, offer more competitive pricing, or invest more heavily in product development and marketing. Our competitors' greater resources may enable them to develop superior products or manufacturing processes that could render our approach obsolete or uncompetitive. We may be unable to compete effectively, which could result in loss of market share, pricing pressure, reduced margins, and an inability to achieve our revenue and growth objectives.
Our manufacturing operations depend on a reliable supply of materials, components, and equipment necessary for 3D printing and production. We are vulnerable to supply chain disruptions caused by various factors including global logistics challenges, natural disasters, geopolitical events, trade restrictions, supplier financial difficulties, or shortages of critical materials. Recent global events have demonstrated the fragility of international supply chains and the potential for extended delays in obtaining necessary materials and equipment. Any significant disruption in our supply chain could result in production delays, increased costs, inability to fulfill customer orders, and damage to our reputation. We may have limited alternative suppliers for certain specialized materials or components, which increases our vulnerability to supply chain risks. Such disruptions could materially harm our business operations and financial performance.	As a manufacturing company, we face potential liability for defects in our products that could result in property damage, personal injury, or other harm to customers or third parties. Product liability claims, whether or not meritorious, could be costly to defend, result in substantial monetary damages, harm our reputation, and divert management's attention from operating our business. We may not maintain adequate product liability insurance coverage, and any claims that exceed our coverage limits could have a material adverse effect on our financial condition. Additionally, depending on the nature of our products and their intended uses, we may be subject to various federal, state, and local regulations governing product safety, quality standards, environmental compliance, and manufacturing practices. Compliance with these regulations may require significant expenditures, and failure to comply could result in fines, penalties, product recalls, or restrictions on our ability to conduct business.
Our success depends in part on our ability to protect our proprietary manufacturing processes, product designs, software, and other intellectual property. We may rely on a combination of trade secrets, confidential know-how, and potentially patents or trademarks to protect our intellectual property rights. However, the steps we take to protect our intellectual property may be inadequate, and we cannot guarantee that our proprietary rights will not be challenged, invalidated, or circumvented. Third parties may independently develop similar technologies or products, or may infringe upon our intellectual property rights. Conversely, we may face claims that our products or processes infringe upon the intellectual property rights of others, which could result in costly litigation, licensing fees, or requirements to redesign our products. As an early-stage company with limited financial resources, we may lack the funds necessary to adequately protect our intellectual property or to defend against infringement claims, which could materially harm our competitive position and business prospects.	Our business operations, including our manufacturing systems, engineering processes, and business records, depend on information technology systems and digital infrastructure. We face risks from cybersecurity threats, including hacking, malware, ransomware, phishing attacks, and other attempts to gain unauthorized access to our systems or data. A successful cyberattack could result in theft of our intellectual property, disruption of our manufacturing operations, loss of sensitive business or customer information, reputational harm, and significant costs to remediate the breach and restore our systems. As we expand our operations and hire additional personnel, our attack surface and vulnerability to cyber threats will increase. We may be subject to data protection and privacy laws that require us to implement specific security measures and notify affected parties in the event of a data breach. Our failure to adequately protect our systems and data could result in operational disruptions, legal liability, regulatory penalties, and loss of customer trust.
The securities being offered are Simple Agreements for Future Equity (SAFEs), which are not traditional debt or equity securities. SAFEs have no maturity date and do not accrue interest, meaning there is no specified time by which investors will receive equity or a return of their investment. The SAFEs will convert into equity only upon the occurrence of specific future events, such as a qualified financing round or liquidity event, which may never occur. The amount and type of equity investors receive upon conversion will depend on the terms of the future financing or liquidity event, the valuation of the company at that time, and the specific terms of the SAFE, including the valuation cap and discount rate. There is significant uncertainty regarding if and when conversion will occur, what the company's valuation will be at conversion, and how much equity investors will ultimately receive. If the company does not raise additional capital or achieve a liquidity event, the SAFEs may never convert, and investors may never realize any return on their investment.	An investment in Metroair, Inc. is highly speculative and involves a substantial risk of loss. Investors should be prepared to lose their entire investment. We are an early-stage company with a limited operating history, unproven business model, limited cash reserves, and no assurance of future revenue or profitability. The likelihood of success for early-stage companies is low, and many such companies fail to achieve their business objectives and ultimately cease operations. Given our current stage of development, operational challenges, and the competitive nature of our industry, there is a significant possibility that we will be unable to execute our business plan, achieve profitability, or provide any return to investors. Only investors who can afford to lose their entire investment and who understand the high-risk nature of early-stage company investments should consider participating in this offering.
We will need to raise substantial additional capital in the future to fund our operations and execute our business plan. Any future issuances of equity securities, whether through subsequent financing rounds, employee stock option plans, convertible debt, or other equity-based arrangements, will dilute the ownership percentage of existing investors. While the SAFE securities include certain protective provisions such as a valuation cap, discount rate, and Most Favored Nation clause, these provisions provide only limited protection against dilution. Future investors may negotiate terms that are more favorable than those provided to SAFE holders, and we may issue securities with rights, preferences, or privileges that are senior to those held by SAFE investors. As we raise additional capital, the percentage ownership that investors receive upon conversion of their SAFEs may be significantly less than anticipated, and the value of their investment may be substantially reduced. There is no limit on the amount of securities we may issue in the future, and investors should expect significant dilution of their ownership stake.	Investors in this offering will have no voting rights, no ability to influence company decisions, and no control over our business operations or strategy. All decisions regarding our business, including decisions about raising additional capital, entering into material contracts, hiring or terminating employees, selling the company, or dissolving the business, will be made by our management and any future board of directors without input from SAFE holders. Even after the SAFEs convert into equity, investors will hold only a minority interest and will be unable to control or significantly influence company decisions. Unlike investors in registered public companies, SAFE holders and future equity holders will have limited information rights and will not be entitled to regular financial reports, audited financial statements, or other disclosures typically available to public company shareholders. Investors must rely entirely on management's judgment and integrity in operating the business and making decisions that affect the value of their investment.
Jisu Kim, CCO of Metroair, Inc. has designated themselves as the lead investor who will sign documents and make decisions on behalf of all investors in the special purpose vehicle (SPV) structure. This arrangement creates significant conflicts of interest because the CCO simultaneously represents the interests of the company and the interests of the investors, which may not always align. This individual has incentives to make decisions that benefit the company's operations, growth, or their personal interests, even when such decisions may not be in the best interests of outside investors. The CCO will have access to material non-public information about the company's financial condition, business prospects, and strategic plans that other investors do not have, creating an information asymmetry that could be used to their advantage. There is no independent third-party investor advocate or fiduciary representing the interests of crowdfunding investors. Investors should be aware that the person making decisions on their behalf has inherent conflicts and may prioritize the company's interests or their own interests over those of minority investors. This structure provides investors with no independent oversight or protection of their investment interests.	

The Offering

USE OF FUNDS

9. What is the purpose of this offering?

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering? ⁽²⁾

If we raise: **\$50,000**

Use of Proceeds: If only the minimum target amount is raised, Metroair expects to use proceeds approximately as follows: 36% 3D Printing Equipment Expansion, 32% Core Engineering Team Hiring, 24.1% Multicruiser Prototype Development, and 7.9% Wefunder fee and related offering expenses. Management intends to allocate proceeds as described but may adjust priorities based on operational needs, supplier availability, and manufacturing timelines.

If we raise: **\$1,235,000**

Use of Proceeds: If the maximum offering amount is raised, including any oversubscriptions, Metroair expects to use proceeds approximately as follows: 27% Factory Floor Build-Out, 18% 3D Printing Fleet Scaling, 23% Hardware & Software Engineering Hires, 13% Quality Assurance Team & Systems, 11.1% Mass Production Readiness & Supply Chain, and 7.9% Wefunder fee and related offering expenses. Management expects to allocate excess proceeds toward expanded manufacturing and team growth but may adjust based on production milestones, partner agreements, and market conditions.

DELIVERY & CANCELLATIONS

11. How will the issuer complete the transaction and deliver securities to the investors?

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

NOTE: Investors may cancel an investment commitment until 48 hours prior to the deadline identified in these offering materials.

The intermediary will notify investors when the target offering amount has been met. If the issuer reaches the target offering amount prior to the deadline identified in the offering materials, it may close the offering early if it provides notice about the new offering deadline at least five business days prior to such new offering deadline.

If an investor does not cancel an investment commitment before the 48-hour period prior to the offering deadline, the funds will be released to the issuer upon closing of the offering and the investor will receive securities in exchange for his or her investment.

If an investor does not reconfirm his or her investment commitment after a material change is made to the offering, the investor's investment commitment will be canceled and the committed funds will be returned.

An investor's right to cancel. An investor may cancel his or her investment commitment at any time until 48 hours prior to the offering deadline.

If there is a material change to the terms of the offering or the information provided to the investor about the offering and/or the Company, the investor will be provided notice of the change and must re-confirm his or her investment commitment within five business days of receipt of the notice. If the investor does not reconfirm, he or she will receive notifications disclosing that the commitment was cancelled, the reason for the cancellation, and the refund amount that the investor is required to receive. If a material change occurs within five business days of the maximum number of days the offering is to remain open, the offering will be extended to allow for a period of five business days for the investor to reconfirm.

Ownership and Capital Structure

THE OFFERING

13. Describe the terms of the securities being offered.

To view a copy of the SAFE you will purchase, please see [Appendix B, Investor Contracts](#). The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides investors the right to **Preferred Stock** in the Company ("Preferred Stock"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Stock**, investors will receive a number of shares of **Preferred Stock** calculated using the method that results in the greater number of **Preferred Stock**:

the total value of the investor's investment, divided by
the price of **Preferred Stock** issued to new investors multiplied by
the **discount rate** (80%), or

if the valuation for the company is more than **\$15,000,000.00** (the "Valuation Cap"), the amount invested by the investor divided by the quotient of

the Valuation Cap divided by

the total amount of the Company's capitalization at that time.

For investors up to the first **\$150,000.00** of the securities, investors will receive a valuation cap of **\$12,000,000.00** and 20% discount.

Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the threshold limit noted above is met.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

Includes all shares of Capital Stock issued and outstanding;

Includes all Converting Securities;

Includes all (i) issued and outstanding Options and (ii) Promised Options; and

Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

22. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

An Investor in the Company will likely hold a minority position in the Company, and thus be limited as to its ability to control or influence the governance and operations of the Company.

The marketability and value of the Investor's interest in the Company will depend upon many factors outside the control of the Investor. The Company will be managed by its officers and be governed in accordance with the strategic direction and decision-making of its Board Of Directors, and the Investor will have no independent right to name or remove an officer or member of the Board Of Directors of the Company.

Following the Investor's investment in the Company, the Company may sell interests to additional investors, which will dilute the percentage interest of the Investor in the Company. Management's Discussion and Analysis of Financial Condition and Results of Operations

Overview of the Business and Financial Condition

Metroair, Inc. (the "Company") was incorporated in the State of Delaware on May 1, 2025. The Company is a pre-revenue, inception-stage entity. The Company is 100% owned by its founder and CEO, Hak Yoon Kim, who serves as the sole controlling owner. Mr. Kim also owns approximately 99% of the Company's Korean affiliated (sister) company under common control of Mr. Kim, Metroair Co., Ltd.

The Company was formed to develop and commercialize guarded hybrid eVTOL (electric vertical takeoff and landing) drones, which are capable of both hovering like a multicopter and cruising like a fixed-wing aircraft. The Company's initial commercial product in development is the Multicruiser FPV drone, targeted at first-person view (FPV) racing, defense, and commercial drone operators primarily in the U.S. market. Long-term expansion plans include targeting segments such as cinematography, industrial inspection, public safety, and last-mile urban logistics.

We are an early-stage company and are currently operating at approximately break-even, with no material positive or negative cash flows from operations in recent periods. There can be no assurance that this break-even performance will continue in future periods.

As of July 15, 2026, we had cash and cash equivalents of approximately \$25,955.

Our ability to continue operations is dependent on managing our expenses and, if necessary, obtaining additional financing.

This discussion should be read in conjunction with the financial statements and related notes included in this offering statement.

Business and Operating Uncertainty

Our business operates in an environment subject to various risks, uncertainties, and changing conditions, which makes it difficult to evaluate our business, financial condition, and prospects and may limit the comparability of our results of operations from period to period.

Financial Condition

As of December 31, 2025, our total assets were \$0 and our current and non-current liabilities, as reflected in available financial statement fields, were \$0.

Our financial statements reflect an early-stage company with limited operating history. Investors should not place undue reliance on historical financial information given the company's limited operating history and the likelihood that future results will differ from historical results.

Liquidity and Capital Resources

As of December 31, 2025, we did not have any cash or cash equivalents on hand.

Based on our current operations, we are operating at approximately break-even, with monthly net cash flow of approximately \$0.

Our monthly net cash burn or profit may vary significantly from month to month due to the timing of receipts and expenditures and other short-term factors. As a result, period-to-period comparisons may not be meaningful.

Based on our current plan, we are not sure if we will have sufficient cash to fund operations for at least the next 12 months. The factors affecting our uncertainty are:

- When customers pay us
- Whether or when we hire more people
- A one-time cost (legal, settlement, equipment, etc.)

To date, our operations have been funded through minimal cash resources and have not included any external financing.

Liquidity Assumptions

Our assessment of our liquidity and ability to fund operations is not a projection and is based on current assumptions regarding operating expenses, cash requirements, and capital needs. These assumptions may change, and actual results may differ materially due to changes in operating conditions, timing of receipts and payments, and other factors.

Dependence on Additional Financing

There can be no assurance that additional financing will be available on acceptable terms, or at all. If we are unable to raise additional capital when needed, we may be required to materially reduce or suspend operations.

Indebtedness and Capital Structure

As of the date of this offering statement, we did not have any outstanding indebtedness.

(For the avoidance of doubt, SAFEs are not treated as indebtedness.)

We have not conducted any exempt offerings or raised capital in the past three years.

Known Trends, Events, and Uncertainties

Management is not currently aware of any known trends, events, or uncertainties that are reasonably likely to have a material adverse effect on our financial condition or results of operations over the next 12 months.

The Lead Investor. As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that Investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an individual that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such circumstances, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. Potential Dissolution of the SPV.
