Summary

Michael Mammoliti is an American film producer and entrepreneur, best known as the co-founder and CEO of 32Red Entertainment. He focuses on film financing, deal structuring, and the development of commercially driven projects. With a background in finance, Mammoliti entered the entertainment industry as a Producer, concurrently while running a company. His approach emphasized securing capital for mid- to high-budget productions while collaborating with filmmakers to create projects with strong commercial appeal. Through 32Red Entertainment, he has worked to build a slate that blends creative storytelling with disciplined financial strategy. 32Red Entertainment, which Mammoliti co-founded with Manasvi Mamgai, operates with an international footprint, including bases in Los Angeles and Mumbai. The company specializes in raising capital for film and television projects, with a focus on protecting investors while supporting bold, marketable content. The team also includes partners and collaborators with experience in production, finance, and strategic development. Mammoliti is a producer on *Captivated*, a feature film directed by Dito Montiel and starring Al Pacino and Katie Holmes. Inspired by the 1973 kidnapping of John Paul Getty III, the project presents a dramatized perspective on the events. Mammoliti also received a story credit on the film, contributing to its narrative development. His producing credits extend across multiple genres and formats. He produced the horror-thriller *The Him*, currently in post-production, and served as co-producer on the feature *Chapel*. Additional projects include *Neon Candy* w/ Jamie King (in development) and a broader slate featuring titles such as the Elmore Leonard novel *Mr. Paradise* directed by Thora Birch, and *Alula* which is being directed by Frank Coraci - who's films have grossed over \$1.7B in the box office.
