These securities have not been recommended or approved by any federal or state securities commission or regulatory authority. Furthermore, these authorities have not passed upon the accuracy or adequacy of this document.

The U.S. Securities and Exchange Commission does not pass upon the merits of any securities offered or the terms of the offering, nor does it pass upon the accuracy or completeness of any offering document or literature.

These securities are offered under an exemption from registration; however, the U.S. Securities and Exchange Commission has not made an independent determination that these securities are exempt from registration.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a

liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

We have incurred operating losses since our inception in May 2025 and expect to continue to incur significant losses as we invest in product development, manufacturing, sales and marketing, and customer support. We have only recently achieved production-ready status and have not yet demonstrated our ability to generate sustained revenue or achieve profitability. Our path to profitability is uncertain and depends on numerous factors, many of which are beyond our control, including our ability to sell robots at scale, achieve acceptable gross margins on hardware sales, control manufacturing and operating costs, and successfully compete against other robotics companies and traditional labor solutions. We expect our operating expenses to increase substantially as we attempt to scale manufacturing, expand our sales efforts, hire additional personnel, and invest in research and development for future product generations. Even if we achieve revenue growth, we may not be able to achieve or sustain profitability. If we are unable to achieve and sustain profitability, our business may fail and investors could lose their entire investment.

Our business model depends on convincing restaurants, hotels, and other hospitality businesses to purchase our robots and integrate them into their operations. The hospitality industry has traditionally relied on human workers for customer-facing tasks, and many businesses and their customers may be hesitant to adopt robotic solutions. Potential customers may have concerns about the cost of our robots, the complexity of integrating them into existing operations, the reliability of autonomous systems, the reaction of their customers to robot service, potential negative impacts on their brand image, or resistance from their workforce. Additionally, the hospitality industry is characterized by relatively thin profit margins, and businesses may be unwilling or unable to make the substantial capital investment required to purchase our robots, particularly during economic uncertainty or labor market changes. If we are unable to demonstrate clear return on investment, reliable performance, and positive customer acceptance, we may fail to achieve significant market penetration, which would prevent us from generating the revenue necessary to sustain and grow our business.

StarBot Inc was incorporated in May 2025 and only achieved production-ready status in February 2026. We have minimal operating history upon which investors can evaluate our business model, technology, or market potential. Our StarBot Nova robot has only recently been launched commercially, and we have not yet demonstrated sustained market acceptance, reliable revenue generation, or the ability to operate profitably. Our business is subject to all the risks inherent in a new enterprise, including the substantial possibility that we will not be able to successfully implement our business plan, achieve market acceptance for our robots, or ever achieve profitability. The likelihood of our success must be considered in light of the problems, expenses, difficulties, complications, and delays frequently encountered in connection with the development of a new business and the competitive and regulatory environment in which we operate.

Our success depends substantially on the continued services and performance of our small team of approximately ten employees, including our founders and key engineering personnel who have developed our robotics technology and autonomous navigation systems. The development of humanoid service robots requires highly specialized expertise in robotics, artificial intelligence, mechanical engineering, and software development. The loss of one or more key employees could significantly delay our product development, impair our ability to deploy and support our robots in the field, and damage relationships with hospitality partners. We face intense competition for qualified personnel in the robotics and AI fields, particularly in the Santa Barbara area and broader California market. We do not maintain key person life insurance on any of our personnel. If we are unable to retain our current team or attract additional qualified personnel as we attempt to scale, our business, financial condition, and results of operations could be materially and adversely affected.

Our StarBot Nova robot is built upon the Unitree G1 research platform, which we acquired for research and development purposes. Our business model and product development roadmap depend significantly on our continued ability to source, modify, and integrate this third-party robotics platform. Any disruption in our relationship with Unitree or changes to the availability, pricing, or specifications of the G1 platform could require us to redesign our robots, seek alternative platforms, or develop proprietary hardware from scratch, any of which would require substantial time and capital investment. Additionally, we depend on various other suppliers for critical components including sensors, processors, batteries, and other hardware necessary for our robots to function. Supply chain disruptions, component shortages, price increases, quality issues, or the inability of suppliers to meet our demand could delay production, increase our costs, or prevent us from fulfilling customer orders, any of which could materially harm our business.

The StarBot Nova is a sophisticated autonomous robot with dual robotic arms, navigation systems, and AI-powered interaction capabilities designed to operate in public spaces alongside customers and employees. Despite our testing and quality control efforts, our robots may contain hardware defects, software bugs, or design flaws that could cause them to malfunction, perform unreliably, or fail to meet customer expectations. Robots operating in restaurants, hotels, and retail environments face unpredictable conditions including spills, obstacles, crowds, and interactions with untrained individuals. Any failure of our robots to navigate safely, handle objects properly, or interact appropriately with customers could result in injury to persons, damage to property, or disruption of our customers' business operations. Such incidents could result in product liability claims, warranty claims, damage to our reputation, loss of customers, and regulatory scrutiny. Even if claims against us are not successful, the cost of defending against such claims and any resulting negative publicity could significantly harm our business and financial condition.

The development, manufacturing, and commercialization of robotics hardware requires substantial capital investment. We will need significant additional funding beyond this offering to scale manufacturing, build inventory, expand our engineering team, conduct pilot programs, support deployed robots in the field, and fund ongoing operations until we can achieve positive cash flow from operations, if ever. We do not currently have commitments for additional financing, and we cannot assure you that additional funding will be available on acceptable terms, or at all. Our ability to raise additional capital will depend on numerous factors, including our progress in product development and commercialization, market conditions, investor sentiment toward robotics companies, and the overall availability of capital. If we are unable to raise sufficient additional capital when needed, we may be forced to delay, reduce, or eliminate our product development programs, reduce our workforce, curtail our marketing and sales efforts, or cease operations entirely. Any additional equity financing would result in dilution to existing investors, and debt financing, if available, may involve restrictive covenants that limit our operating flexibility.

The robotics and automation industry is highly competitive and rapidly evolving, with numerous companies developing service robots for hospitality and commercial applications. We compete against large, well-established technology companies with substantially greater financial resources, technical capabilities, manufacturing capacity, brand recognition, and customer relationships than we have. These competitors may be able to develop superior products, bring them to market more quickly, price them more competitively, or provide better customer support than we can. Additionally, we face competition from traditional automation solutions, labor agencies, and the option for businesses to simply hire human workers rather than invest in robotics. Some competitors have already deployed robots at scale in commercial environments and have more extensive operational data and customer references than we do. Our ability to compete successfully will depend on our ability to demonstrate superior performance, reliability, and return on investment compared to alternatives, which we may not be able to achieve. If we cannot compete effectively, we may be unable to acquire customers, generate revenue, or achieve our business objectives.

Our business depends on a complex global supply chain for robotics components, sensors, processors, batteries, motors, and other hardware. The robotics industry has experienced significant supply chain challenges, including semiconductor shortages, shipping delays, increased freight costs, and geopolitical tensions affecting manufacturing and trade. We have limited control over our suppliers and may face difficulties obtaining components in sufficient quantities, at acceptable prices, or on a timely basis. As a small company with limited purchasing power, we may not be prioritized by suppliers during periods of high demand or constrained supply. Any significant disruption to our supply chain could delay production, prevent us from fulfilling customer orders, increase our manufacturing costs, or force us to redesign our products to use alternative components. Additionally, as we are building robots based on a platform from a Chinese manufacturer (Unitree), we face particular risks related to U.S.-China trade relations, tariffs, export controls, and potential restrictions on technology transfer, any of which could significantly impact our ability to source critical components or platforms.

Our robots are designed to operate autonomously in restaurants, hotels, and other public spaces where they will interact with customers, employees, and the general public. The regulatory framework governing autonomous robots in commercial and public environments is still developing and varies by jurisdiction. We may become subject to federal, state, or local regulations related to robot safety standards, autonomous navigation requirements, data collection and privacy, accessibility for persons with disabilities, and operational restrictions. Regulatory agencies such as OSHA, the CPSC, or state-level authorities may impose requirements on the design, testing, certification, or operation of our robots that could increase our costs, delay our product launches, or limit where and how our robots can be deployed. Additionally, there is uncertainty regarding liability standards and insurance requirements for autonomous robots that cause injury or property damage. Changes in laws or regulations, or new interpretations of existing laws, could require us to modify our products, obtain certifications or approvals, or cease operations in certain jurisdictions, any of which could materially harm our business.

Our StarBot Nova robots are equipped with sensors, cameras, microphones, and AI systems that collect and process data to enable autonomous navigation and multilingual voice interaction. This data collection occurs in hospitality environments where customer privacy expectations are high and where sensitive personal information may be present. We are subject to various federal and state data privacy and security laws and regulations, including the California Consumer Privacy Act and other state privacy laws, which impose obligations regarding the collection, use, storage, and protection of personal information. Our customers may also impose contractual requirements regarding data handling and security. Any actual or perceived failure to protect customer data, unauthorized access to our systems, data breaches, or misuse of collected information could result in regulatory investigations, fines, lawsuits, loss of customer trust, and reputational harm. Additionally, as data privacy regulations continue to evolve and become more stringent, we may face increased compliance costs and operational restrictions that could adversely affect our business model and profitability.

Our success depends in part on our ability to protect our proprietary technology, including our software algorithms for autonomous navigation, manipulation, and AI interaction, as well as our hardware designs and integration methods. We rely primarily on trade secrets, confidential know-how, and contractual protections rather than patents to protect our intellectual property. However, trade secrets can be difficult to protect, and employees, contractors, or partners may inadvertently or intentionally disclose our proprietary information. Competitors may independently develop similar technologies or reverse-engineer our products. Additionally, because the robotics industry involves complex technology that may implicate numerous patents held by others, we face the risk that third parties may claim that our products infringe their intellectual property rights. Defending against such claims, even if meritless, could be costly and time-consuming and could divert management attention from operating our business. If we are found to infringe third-party intellectual property rights, we could be required to pay damages, obtain licenses (which may not be available on acceptable terms), modify our products, or cease selling our robots, any of which could materially harm our business and financial condition.

The securities being offered are Simple Agreements for Future Equity (SAFEs), which are not shares of stock and do not represent current ownership in the company. A SAFE is a contractual right to receive equity in the future upon the occurrence of specific triggering events, such as a future priced equity financing or a liquidity event. However, there is no guarantee that any such triggering event will occur. If the company does not raise a future priced equity round, does not achieve a liquidity event, and does not dissolve, your SAFE may never convert into equity and you may never realize any return on your investment. Even if your SAFE does convert, the amount of equity you receive will depend on the terms of the future financing or liquidity event, which are currently unknown and will be determined by negotiations between the company and future investors in which you will have no involvement. The valuation cap and discount rate in your SAFE provide some downside protection, but there is no guarantee that the equity you ultimately receive will be valuable or that you will be able to recover your investment. SAFEs have no maturity date and do not accrue interest, so your funds may be tied up indefinitely without any return.

An investment in these securities is highly speculative and involves a high degree of risk. You should invest only if you can afford to lose your entire investment. The securities have not been registered under the Securities Act of 1933 or any state securities laws and are being offered pursuant to exemptions from registration. As a result, the securities are subject to restrictions on transfer and resale, and you will be required to hold your securities for an indefinite period of time. There is no public market for these securities, and we do not expect one to develop. Even after any applicable holding period expires, you may not be able to sell your securities because there is unlikely to be any market for them. The company is under no obligation to register the securities for resale or to assist you in finding a buyer. Additionally, as a holder of SAFEs or equity in a private company, you will have extremely limited liquidity options. Your ability to realize any value from your investment will likely depend entirely on the company achieving a liquidity event such as an acquisition or initial public offering, which may never occur. You should be prepared to hold your investment indefinitely and to lose your entire

investment.

In this offering structure, the founder of StarBot Inc has designated themselves to serve as the lead investor who will sign documents and make decisions on behalf of all crowdfunding investors participating through a special purpose vehicle (SPV). This arrangement creates a fundamental and inherent conflict of interest. The founder's primary duty and economic interest is to the company and its success, which may not always align with the interests of investors. For example, decisions regarding the timing and terms of future financings, acquisition offers, dissolution, or other material corporate actions may benefit the company or the founder personally while being disadvantageous to investors. The founder will have access to material non-public information about the company's financial condition, prospects, and challenges that will not be shared with investors, creating an information asymmetry that could affect decision-making. Unlike a typical investment structure where an independent third party represents investor interests and can advocate for investor protections, negotiate terms, or challenge company decisions, you will have no independent advocate. The founder may prioritize the company's need for flexibility and capital over investor protections or returns. This conflict is inherent in the structure and cannot be eliminated, and you should assume that in any situation where the interests of the company and investors diverge, decisions will be made in favor of the company.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Offering

USE OF FUNDS

9. What is the purpose of this offering?

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering? ⓘ

If we raise: **\$50,000**

Use of Proceeds: If only the minimum target amount is raised, expected use of proceeds is approximately 41% product development, 23% hiring and payroll, 13% sales and marketing, 15.1% working capital and general corporate purposes, 7.9% Wefunder fee and related offering expenses. The issuer intends to prioritize essential operating execution and near-term milestones, and management may reallocate among categories based on hiring pace, customer demand, market conditions, and timing of expenditures.

If we raise: **\$124,000**

Use of Proceeds: At the higher funding level, expected use of proceeds is approximately 25% product development and technology, 20% hiring and payroll, 23% sales and marketing, 24.1% working capital, operating reserves, and strategic initiatives, 7.9% Wefunder fee and related offering expenses. If we reach our maximum raise target, we plan to accelerate multi-location deployments, expand our robotics engineering team, and strengthen our AI software platform for commercial service environments.

DELIVERY & CANCELLATIONS

11. How will the issuer complete the transaction and deliver securities to the investors?

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **Preferred Stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Stock**, **Investors will receive a number of shares of Preferred Stock** calculated using the method that results in the greater number of **Preferred Stock**:

- the total value of the Investor's investment, divided by
- the price of **Preferred Stock** issued to new Investors multiplied by
- the **discount rate** (90%), or
- if the valuation for the company is more than **\$25,000,000.00** (the "Valuation Cap"), the amount invested by the Investor divided by
- the quotient of
- the Valuation Cap divided by
- the total amount of the Company's capitalization at that time.

Voting Rights If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the articles of incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. The offering price for the securities offered pursuant to this Form C has been determined arbitrarily by the Company, and does not necessarily bear any relationship to the Company's book value, assets, earnings or other generally accepted valuation criteria. In determining the offering price, the Company did not employ investment banking firms or other outside organizations to make an independent appraisal or evaluation. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

The initial amount invested in a SAFE is determined by the investor, and we do not guarantee that the SAFE will be converted into any particular number of **shares of Preferred Stock**. As discussed in Question 13, when we engage in an offering of equity interests involving **Preferred Stock**, Investors may receive a number of shares of **Preferred Stock** calculated as either (i) the total value of the Investor's investment, divided by the price of the **Preferred Stock** being issued to new Investors, or (ii) if the valuation for the company is more than the Valuation Cap, the amount invested divided by the quotient of (a) the Valuation Cap divided by (b) the total amount of the Company's capitalization at that time.

directors. Among the factors we may consider in determining the price of **Preferred Stock** are prevailing market conditions, our financial information, market valuations of other companies that we believe to be comparable to us, estimates of our business potential, the present state of our development and other factors deemed relevant.

In the future, we will perform valuations of our **stock (including both common stock and Preferred Stock)** that take into account, as applicable, factors such as the following:

- unrelated third party valuations;
- the price at which we sell other securities in light of the relative rights, preferences and privileges of those securities;
- our results of operations, financial position and capital resources;
- current business conditions and projections;
- the marketability or lack thereof of the securities;
- the hiring of key personnel and the experience of our management;
- the introduction of new products;
- the risk inherent in the development and expansion of our products;
- our stage of development and material risks related to our business;
- the likelihood of achieving a liquidity event, such as an initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;
- industry trends and competitive environment;
- trends in consumer spending, including consumer confidence;
- overall economic indicators, including gross domestic product, employment, inflation and interest rates; and
- the general economic outlook.

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

22. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

An Investor in the Company will likely hold a minority position in the Company, and thus be limited as to its ability to control or influence the governance and operations of the Company.

The marketability and value of the Investor's interest in the Company will depend upon many factors outside the control of the Investor. The Company will be managed by its officers and be governed in accordance with the strategic direction and decision-making of its Board Of Directors, and the Investor will have no independent right to name or remove an officer or member of the Board Of Directors of the Company.

Following the Investor's investment in the Company, the Company may sell interests to additional investors, which will dilute the percentage interest of the Investor in the Company. The Investor may have the opportunity to increase its investment in the Company in such a transaction, but such opportunity cannot be assured.

The amount of additional financing needed by the Company, if any, will depend upon the maturity and objectives of the Company. The declining of an opportunity or the inability of the Investor to make a follow-on investment, or the lack of an opportunity to make such a follow-on investment, may result in substantial dilution of the Investor's interest in the Company.

Additional issuances of securities. The amount of additional financing needed by the Company, if any, will depend upon the maturity and objectives of the Company. The declining of an opportunity or the inability of the Investor to make a follow-on investment, or the lack of an opportunity to make such a follow-on investment, may result in substantial dilution of the Investor's interest in the Company.

Issuer repurchases of securities. Management's Discussion and Analysis of Financial Condition and Results of Operations

Overview of the Business and Financial Condition

StarBot USA is a Santa Barbara-based robotics startup building intelligent humanoid service robots for the hospitality industry. They develop autonomous robots that work alongside people to handle repetitive tasks, allowing human staff to focus on genuine hospitality.

We are an early-stage company and have incurred operating losses and negative cash flows from operations since inception. We expect to continue to incur operating losses in the near term.

As of August 1, 2026, we had cash and cash equivalents of approximately \$40,000.

Our ability to continue operations is dependent on managing our expenses and, if necessary, obtaining additional financing.

This discussion should be read in conjunction with the financial statements and related notes included in this offering statement.

Business and Operating Uncertainty

Our business operates in an environment subject to various risks, uncertainties, and changing conditions, which makes it difficult to evaluate our business, financial condition, and prospects and may limit the comparability of our results of operations from period to period.

Financial Condition

As of December 31, 2025, our total assets were \$420,000 and our current and non-current liabilities, as reflected in available financial statement fields, were \$0.

Our financial statements reflect an early-stage company with limited operating history. Investors should not place undue reliance on historical financial information given the company's limited operating history and the likelihood that future results will differ from historical results.

Liquidity and Capital Resources

As of December 31, 2025, we did not have any cash or cash equivalents on hand.

Based on our current operations, we have a monthly net cash burn of approximately \$8,000.

Our monthly net cash burn or profit may vary significantly from month to month due to the timing of receipts and expenditures and other short-term factors. As a result, period-to-period comparisons may not be meaningful.

Based on our current plan, we expect to have sufficient cash to fund operations for at least the next 12 months.

To date, our operations have been funded through minimal cash resources and have not included any external financing.

Liquidity Assumptions

Our assessment of our liquidity and ability to fund operations is not a projection and is based on current assumptions regarding operating expenses, cash requirements, and capital needs. These assumptions may change, and actual results may differ materially due to changes in operating conditions, timing of receipts and payments, and other factors.

Dependence on Additional Financing

There can be no assurance that additional financing will be available on acceptable terms, or at all. If we are unable to raise additional capital when needed, we may be required to materially reduce or suspend operations.

Indebtedness and Capital Structure

As of the date of this offering statement, we did not have any outstanding indebtedness.

(For the avoidance of doubt, SAFEs are not treated as indebtedness.)

We have not conducted any exempt offerings or raised capital in the past three years. The founder has contributed approximately \$700,000 to the company to date. These funds have been used to support research and development, prototype development, equipment purchases, software development, and operating expenses.

Known Trends, Events, and Uncertainties

Management is not currently aware of any known trends, events, or uncertainties that are reasonably likely to have a material adverse effect on our financial condition or results of operations over the next 12 months.

The absence of a discussion of any particular trend, event, or uncertainty should not be interpreted to mean that such matters do not exist; rather, it reflects management's judgment based on information currently available.

Changes Since the Date of the Financial Statements

There have been no material changes in our operations or financial condition since the date of the financial statements included in this offering.

The proceeds from this offering are expected to be used to scale real-world deployment of StarBot service robots, improve autonomous navigation and AI interaction systems, support pilot programs with hospitality and retail partners, and expand manufacturing and engineering operations. If we reach our maximum, the timing and extent of our use of proceeds will depend on the amount of proceeds raised and future operating conditions. Additional detail regarding our planned use of proceeds is provided in Item 10 of this Form C.

There can be no assurance that the proceeds of this offering will be sufficient to fund our operations or achieve our business objectives.

The Lead Investor. As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that Investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an individual that is chosen to act in the role of Lead Investor on behalf of investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such circumstances, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Potential Dissolution of the SPV.
