Contingent Coupon Payments (with Memory Feature)	On each contingent coupon payment date, unless the securities have been automatically called, you will receive a contingent coupon payment at a per annum rate equal to the contingent coupon rate (each a "contingent coupon payment") if, and only if, the stock closing price of the Underlying Stock on the related calculation day is greater than or equal to the coupon threshold price. In addition, if the stock closing price of the Underlying Stock on one or more calculation days is less than the coupon threshold price and, on a subsequent calculation day, the stock closing price of the Underlying Stock on that subsequent calculation day is greater than or equal to the coupon threshold price, on the contingent coupon payment date related to that subsequent calculation day, you will receive the contingent coupon payment due for that subsequent calculation day plus all previously unpaid contingent coupon payments (without interest on amounts previously unpaid). Each contingent coupon payment, if any, will be calculated per security as follows: $(\$1,000 \times \text{contingent coupon rate})/4$.
Contingent Coupon Rate	At least 15.20% per annum, to be determined on the pricing date.
Calculation Days*	Quarterly, on the 23rd of each March, June, September and December, commencing December 2026 and ending September 2029
Contingent Coupon Payment Dates	Quarterly, on the third business day following each calculation day, provided that the contingent coupon payment date with respect to the final calculation day will be the stated maturity date
Automatic Call	If the closing price of the Underlying Stock on any of the calculation days from December 2026 to June 2029, inclusive, is greater than or equal to the starting price, the securities will be automatically called, and on the related call settlement date, you will be entitled to receive a cash payment per security in U.S. dollars equal to the face amount plus the final contingent coupon payment and any previously unpaid contingent coupon payments otherwise due. The securities will be subject to automatic call from the first calculation day, which is approximately three months after the issue date.
Call Settlement Date*	Three business days after the applicable calculation day.
Maturity Payment Amount (per security)	- If the ending price is greater than or equal to the downside threshold price: \$1,000; or - If the ending price is less than the downside threshold price: $\\$1,000 \times (\text{performance factor} + \text{buffer amount})$
Performance Factor	The ending price <i>divided by</i> the starting price (expressed as a percentage).
Starting Price	The stock closing price on the pricing date
Ending Price	The stock closing price on the final calculation day
Buffer Amount	25%
Coupon Threshold Price	75% of its starting price
Downside Threshold Price	75% of its starting price

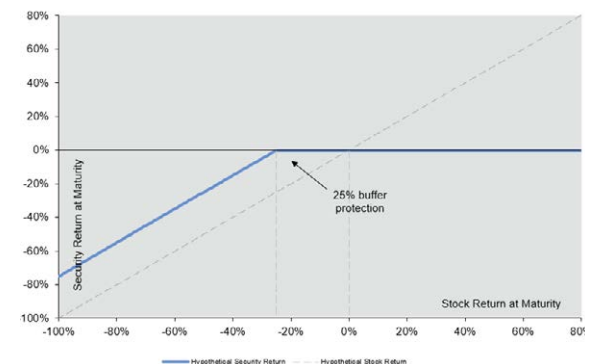

If the securities are not automatically called prior to maturity and the ending price is less than the downside threshold price, you will have 1-to-1 downside exposure to the decrease in the price of the Underlying Stock in excess of the buffer amount and will lose some, and possibly up to 70%, of the face amount of your securities at maturity.

Any positive return on the securities will be limited to the sum of your contingent coupon payments, if any. You will not participate in any appreciation of the Underlying Stock, but you will have up to 75% downside exposure to the Underlying Stock if the ending price is less than the downside threshold price.

The estimated initial value of the securities on the pricing date is expected to be between \$928.00 and \$968.00 per security, which is expected to be less than the price to public. The market value of the securities at any time will reflect many factors and cannot be predicted with accuracy.
