These securities have not been recommended or approved by any federal or state securities commission or regulatory authority. Furthermore, these authorities have not passed upon the accuracy or adequacy of this document.

The U.S. Securities and Exchange Commission does not pass upon the merits of any securities offered or the terms of the offering, nor does it pass upon the accuracy or completeness of any offering document or literature.

These securities are offered under an exemption from registration; however, the U.S. Securities and Exchange Commission has not made an independent determination that these securities are exempt from registration.

Verdi Ergun is a part-time officer. There is potential the company will not move as fast as if this was not the case.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

As a private company conducting an offering under Regulation Crowdfunding, we are subject to significantly less rigorous disclosure and reporting requirements than public companies. While we are required to file annual reports with the Securities and Exchange Commission, these reports will contain less detailed financial and operational information than the reports required of public companies. We are not required to have our financial statements audited unless we raise a certain threshold amount, and we are not subject to the same corporate governance requirements, internal control certifications, or continuous disclosure obligations that apply to public companies. Investors will have limited access to information about our business, financial condition, and operations, and may not receive timely updates about material developments affecting the company. You will have limited ability to monitor your investment or assess our performance, and you may not learn about problems or challenges facing the company until they have become severe. This lack of information may make it difficult for you to make informed decisions about your investment or to protect your interests as a minority investor.

Oravanti Ventures Inc was incorporated in June 2025 and is in the early stages of developing and commercializing its legal operating system platform. We are currently conducting pilot programs with law firms and have not yet achieved significant commercial deployment or proven product-market fit. Our limited operating history makes it difficult for investors to evaluate our business model, assess our prospects, or predict our future performance. We have minimal historical financial data upon which investors can base an evaluation of our business and prospects. The challenges, risks, and difficulties frequently encountered by early-stage companies in rapidly evolving markets like legal technology may prove too difficult for us to address successfully. As an early-stage company with only two employees, we face significant execution risks in completing product development, acquiring customers, scaling operations, and achieving profitability. We may encounter unanticipated problems, expenses, and delays that are common in the development and commercialization of new software platforms. There can be no assurance that our business strategy will be successful or that we will be able to successfully address the challenges we face.

We have not achieved profitability since our inception and have very limited cash reserves. We expect to continue to incur significant operating losses as we complete product development, conduct pilot programs, acquire initial customers, and scale our operations. Our ability to achieve profitability depends on numerous factors, many of which are beyond our control, including our ability to successfully complete our platform, achieve market acceptance among law firms, acquire and retain paying customers, and generate sufficient revenue to cover our operating expenses. The legal technology market is competitive and achieving meaningful market penetration will require substantial investment in product development, sales and marketing, customer support, and infrastructure. Even if we succeed in developing our platform and acquiring customers, we may not achieve sufficient revenue to become profitable or generate positive cash flow. If we are unable to achieve and sustain profitability, investors may lose some or all of their investment.

Our success depends in part on our ability to protect our proprietary technology, software code, methodologies, and other intellectual property rights. We rely primarily on trade secrets, proprietary know-how, confidential information, and contractual protections rather than patents. However, these measures may not adequately protect our intellectual property, and we may not be able to prevent unauthorized use or disclosure of our technology. Competitors or former employees could independently develop similar technology or reverse engineer our platform, which could diminish our competitive advantage.

Additionally, we face the risk that third parties may claim that our platform infringes their intellectual property rights, including patents, copyrights, or trade secrets. The legal technology sector includes numerous companies with existing intellectual property portfolios, and we may face claims of infringement as we develop and commercialize our platform. Defending against such claims, even if meritless, could be expensive and time-consuming, divert management attention, and result in costly settlements or judgments. If we are found to infringe third-party rights, we could be required to pay damages, obtain licenses on unfavorable terms, modify our platform, or cease offering certain features, any of which could materially harm our business.

The legal practice management software market is highly competitive and includes numerous established competitors with significantly greater financial resources, larger customer bases, longer operating histories, stronger brand recognition, and more extensive sales and marketing capabilities than we possess. Competitors include well-established companies offering practice management, case management, document automation, and legal workflow solutions that law firms currently use and may be reluctant to replace. Many of our competitors have the resources to offer more comprehensive solutions, bundle products and services, reduce prices, or provide more favorable terms to customers. They may also have established relationships with law firms and legal industry organizations that could make it difficult for us to gain market acceptance. If we are unable to compete effectively, we may fail to acquire customers, lose market share, experience pricing pressure, or be forced to modify our business strategy in ways that could adversely affect our financial performance and prospects.

We are currently conducting this offering on Wefunder concurrently with a separate offering to accredited investors, and we will need to raise substantial additional capital in the future to fund our operations and growth. Any future issuance of equity securities, whether through private placements, public offerings, or the exercise of convertible securities or options, will dilute the ownership percentage of existing investors, including investors in this offering. As we raise additional capital, your proportionate ownership in the company will decrease, potentially significantly. Future investors may receive securities with rights, preferences, or privileges that are superior to those of the securities offered in this round. For example, future investors may receive preferred stock with liquidation preferences, anti-dilution protections, or other terms that effectively subordinate your investment. We may also issue securities at valuations that are higher or lower than the valuation implied in this offering. If we raise capital at a lower valuation, investors in this offering will experience immediate dilution. The cumulative effect of multiple future financings could substantially reduce the value and ownership percentage represented by your investment.

The proceeds from this offering, together with our concurrent fundraising efforts, are intended to fund product completion, pilot customer acquisition, and initial commercial deployment. However, we will require substantial additional capital beyond this financing to fully develop our business, scale our operations, and achieve profitability. We do not currently have commitments for additional funding, and there can be no assurance that we will be able to raise additional capital on acceptable terms, if at all. Our future capital requirements will depend on many factors, including the pace of product development, the cost of customer acquisition, the rate of market acceptance, competitive pressures, and our ability to generate revenue. If we are unable to obtain sufficient additional financing when needed, we may be required to significantly curtail our operations, delay or abandon product development initiatives, reduce our workforce, or cease operations entirely. Any additional equity financing will result in dilution to existing investors, and debt financing, if available, may impose restrictive covenants that limit our operational flexibility.

As a company with only two employees, our success is highly dependent on the continued service and performance of our founders and key personnel. The loss of either member of our current team would have a material adverse effect on our ability to execute our business plan, complete product development, and achieve our strategic objectives. We do not maintain key person life insurance on any of our personnel, and therefore would not receive any compensation to offset the costs associated with the loss of key employees. As we grow, we will need to attract, hire, train, and retain additional qualified personnel, including software engineers, product managers, sales and marketing professionals, and customer success staff. Competition for qualified personnel in the legal technology sector is intense, particularly in South Florida where we are located. We may not be able to attract and retain the personnel necessary to execute our business strategy. Our inability to hire and retain qualified personnel, or the loss of key members of our small team, could delay product development, impair our ability to acquire and support customers, and materially harm our business prospects.

Our business strategy is based on providing an all-in-one legal operating system that integrates multiple functions including case management, document automation, client communications, staff training, and quality control. This approach requires law firms to consolidate various existing tools and systems into our single platform, which represents a significant change management challenge. Law firms may be reluctant to abandon familiar systems, may face disruption during transition, or may prefer best-of-breed point solutions over an integrated platform. The legal industry has historically been conservative in adopting new technologies, and law firms may be slow to embrace comprehensive platform changes that require retraining staff, migrating data, and modifying established workflows. Our target customers may have existing contracts with other vendors, face switching costs, or encounter resistance from staff accustomed to current systems. If we cannot demonstrate sufficient value to overcome these adoption barriers, or if the market does not embrace our integrated platform approach, our ability to acquire customers and generate revenue will be materially impaired.

We are currently in a pilot and beta phase with law firms while simultaneously working to complete core features of our platform. This approach creates operational challenges as we must allocate our limited resources between ongoing product development, pilot customer support, feedback incorporation, and quality assurance. Supporting pilot customers while the platform is still under development may strain our small team, delay product completion, or result in an incomplete or unstable product experience that could damage our reputation with early adopters. Pilot customers may encounter bugs, missing features, or performance issues that could lead to dissatisfaction, negative word-of-mouth in the legal community, or difficulty converting pilots into paying customers. If we cannot successfully balance product development with pilot support, or if pilot programs reveal fundamental product or market fit issues, we may need to significantly revise our platform, business model, or go-to-market strategy, which could delay commercialization and require additional capital.

As a provider of software to law firms, we are subject to stringent legal and regulatory requirements governing the handling of confidential client information, attorney-client privileged communications, and sensitive legal matter data. Law firms have ethical obligations under state bar rules and professional responsibility codes to protect client confidentiality and maintain data security. Any failure by our platform to adequately protect this information could expose our law firm customers to disciplinary action, malpractice claims, or regulatory penalties, and could result in liability for our company. We must comply with various federal and state data privacy and security laws, including regulations specific to the legal industry. As we develop features involving artificial intelligence and document automation, we may face additional scrutiny regarding the unauthorized practice of law, the appropriate use of AI in legal services, and compliance with evolving regulations governing legal technology. Changes in laws or regulations affecting legal technology providers, or our failure to comply with applicable requirements, could require costly modifications to our platform, limit our ability to offer certain features, result in regulatory penalties, or damage our reputation in the legal community.

Our platform will store and process highly sensitive and confidential information including client data, legal documents, case files, privileged communications, and financial information. We face significant risks from cybersecurity threats, including hacking, phishing, ransomware, malware, and other attacks that could result in unauthorized access to, disclosure of, or loss of this sensitive information. A significant data breach or security incident could expose us and our law firm customers to substantial liability, including claims by affected clients, regulatory investigations and penalties, and litigation. Law firms entrust us with their most sensitive information and any security failure could result in immediate loss of customer confidence, contract terminations, difficulty acquiring new customers, and lasting reputational damage in the legal community where trust and confidentiality are paramount. We may also face claims that we failed to implement adequate security measures or properly protect client

Conductivity are paramount. We may also face claims that we failed to implement adequate security measures or properly protect client data. The costs of responding to a security incident, including forensic investigation, notification obligations, credit monitoring services, legal fees, regulatory penalties, and potential settlements or judgments, could be substantial and could materially harm our financial condition and business prospects.

Our legal operating system platform relies on third-party cloud infrastructure providers, data storage services, communication tools, payment processors, and other technology vendors to deliver our services to law firm customers. We do not control the operation of these third-party services, and any disruption, failure, or degradation in their performance could directly impact our ability to provide reliable service to our customers. Service outages, security breaches at third-party providers, changes in service terms or pricing, or discontinuation of services we depend upon could disrupt our operations and harm our reputation. We may also face challenges if third-party providers change their terms of service, increase prices, limit functionality, or terminate their services. Migrating to alternative providers could be costly, time-consuming, and disruptive to our customers. Additionally, our platform may need to integrate with other legal technology tools, court filing systems, or government databases, and our ability to maintain these integrations depends on the cooperation and technical specifications of these third parties. Any failure to maintain reliable third-party infrastructure or integrations could result in service disruptions, customer dissatisfaction, and loss of business.

Demand for our legal operating system depends on law firms' willingness and ability to invest in new technology and practice management solutions. During economic downturns, recessions, or periods of reduced legal services demand, law firms may reduce discretionary spending on technology, delay purchasing decisions, or seek to reduce operating costs by canceling or downgrading software subscriptions. Small and mid-sized law firms, which may represent a significant portion of our target market, may be particularly sensitive to economic pressures and may prioritize cost reduction over technology investment. Additionally, changes in immigration policy, enforcement priorities, or visa processing volumes could significantly impact immigration law firms, which represent a key target market for our platform given our focus on immigration case workflows. Reduced demand for immigration legal services could lead these firms to reduce technology spending or cease operations entirely. Any sustained economic downturn or reduction in legal services demand could materially reduce our ability to acquire new customers, result in customer churn, and adversely affect our revenue and growth prospects.

An investment in Oravanti Ventures Inc is highly speculative and involves a high degree of risk. You should not invest any funds in this offering unless you can afford to lose your entire investment. We are an early-stage company with a limited operating history, no proven business model, and very limited cash reserves. We may never successfully complete our platform, achieve market acceptance, generate significant revenue, or become profitable. Given our early stage of development and the numerous risks and uncertainties we face, there is a substantial risk that our business will fail and that investors will lose their entire investment. Even if we achieve some level of success, the value of your investment may be significantly less than the amount you invested. You should carefully consider whether you can bear the economic risk of losing your entire investment before deciding to invest in this offering.

There is currently no public market for the securities being offered, and we do not expect that a public market will develop in the foreseeable future. The securities have not been registered under the Securities Act of 1933 or any state securities laws, and may not be sold or transferred except pursuant to an available exemption from registration requirements. Even if you are able to find a buyer for your securities, you will likely face significant restrictions on your ability to transfer them. You should be prepared to hold your investment for an indefinite period of time, potentially until the company is sold or ceases operations. There is no guarantee that you will ever be able to liquidate your investment or that any liquidity event will occur. The lack of liquidity may make it difficult or impossible for you to sell your securities when you want or need to do so, and you should not invest in this offering if you may need access to the funds you invest in the near or medium term.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **Preferred Stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Stock**, **investors will receive a number of shares of Preferred Stock** calculated using the method that results in the greater number of **Preferred Stock**:

the total value of the Investor's investment, divided by

the price of **Preferred Stock** issued to new investors multiplied by

the **discount rate** (90%) (paying 90% of the future share price), or

22. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

An Investor in the Company will likely hold a minority position in the Company, and thus be limited as to its ability to control or influence the governance and operations of the Company.

The marketability and value of the Investor's interest in the Company will depend upon many factors outside the control of the Investor. The Company will be managed by its officers and be governed in accordance with the strategic direction and decision-making of its Board Of Directors, and the Investor will have no independent right to name or remove an officer or member of the Board Of Directors of the Company.

Following the Investor's investment in the Company, the Company may sell interests to additional investors, which will dilute the percentage interest of the Investor in the Company. The Investor may have the opportunity to increase its investment in the Company in such a transaction, but such opportunity cannot be assured.

Management's Discussion and Analysis of Financial Condition and Results of Operations

Overview of the Business and Financial Condition

Oravanti is a comprehensive legal operating system designed specifically for modern law firms, particularly those handling immigration cases. The platform connects case workflows, document processes, staff training, client education, quality-focused AI, financial operations, communications, and analytics in one integrated environment.

We are an early-stage company and have incurred operating losses and negative cash flows from operations since inception. We expect to continue to incur operating losses in the near term. Oravanti Ventures LLC was formed in Florida on June 25, 2025. Effective July 21, 2026, after the balance-sheet date, it completed a statutory conversion to Oravanti Ventures Inc., a Florida profit corporation, retaining the same federal employer identification number. The Company is developing a legal practice-management software platform initially focused on immigration practices.

As of July 31, 2026, we had cash and cash equivalents of approximately \$2,591.42.

Our ability to continue operations is dependent on managing our expenses and, if necessary, obtaining additional financing.

This discussion should be read in conjunction with the financial statements and related notes included in this offering statement.

Business and Operating Uncertainty

Our business operates in an environment subject to various risks, uncertainties, and changing conditions, which makes it difficult to evaluate our business, financial condition, and prospects and may limit the comparability of our results of operations from period to period.

Financial Condition

As of December 31, 2025, our total assets were \$348.42 and our current and non-current liabilities, as reflected in available financial statement fields, were \$0.

Our financial statements reflect an early-stage company with limited operating history. Investors should not place undue reliance on historical financial information given the company's limited operating history and the likelihood that future results will differ from historical results.

Liquidity and Capital Resources

As of December 31, 2025, we did not have any cash or cash equivalents on hand.

Based on our current operations, we have a monthly net cash burn of approximately \$2,589.71.

Our monthly net cash burn or profit may vary significantly from month to month due to the timing of receipts and expenditures and other short-term factors. As a result, period-to-period comparisons may not be meaningful.

Based on our current plan, we do not expect to have sufficient cash to fund operations for at least the next 12 months. The main drivers of our limited runway include:

- When customers pay us
- Whether or when we hire more people

To date, our operations have been funded through minimal cash resources and have not included any external financing.

Liquidity Assumptions

Our assessment of our liquidity and ability to fund operations is not a projection and is based on current assumptions regarding operating expenses, cash requirements, and capital needs. These assumptions may change, and actual results may differ materially due to changes in operating conditions, timing of receipts and payments, and other factors.

Dependence on Additional Financing

There can be no assurance that additional financing will be available on acceptable terms, or at all. If we are unable to raise additional capital when needed, we may be required to materially reduce or suspend operations.

Indebtedness and Capital Structure

As of the date of this offering statement, we had total outstanding indebtedness consisting of 1 loan and approximately \$12,400 in aggregate principal obligations. The material terms of such indebtedness are described in Item 24 of this Form C and include no stated interest rate, no stated maturity date.

(For the avoidance of doubt, SAFEs are not treated as indebtedness.)

We have not conducted any exempt offerings or raised capital in the past three years. Founder has contributed \$25,000 to the company in 2025.

As described above, each investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on investors' behalf.

The Lead Investor is an individual that is chosen to act in the role of Lead Investor on behalf of investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to investors before investors make a final investment decision to purchase the securities related to the Company.
