A crowdfunding investment involves risk. Investors should not invest any funds unless they can afford to lose the entire investment.

In making an investment decision, investors must rely on their own examination of the issuer and the terms of the offering, including the merits and risks involved. These securities have not been recommended or approved by any federal or state securities commission or regulatory authority. Furthermore, these authorities have not passed upon the accuracy or adequacy of this document.

The U.S. Securities and Exchange Commission does not pass upon the merits of any securities offered or the terms of the offering, nor does it pass upon the accuracy or completeness of any offering document or literature.

These securities are offered under an exemption from registration; however, the U.S. Securities and Exchange Commission has not made an independent determination that these securities are exempt from registration.

Red Planet Resorts purports to offer luxury hospitality services on Mars, including interstellar transportation, resort accommodations, and excursions on the Martian surface. However, no commercial infrastructure for Mars tourism currently exists, and the technology required for safe, routine human travel to and habitation on Mars has not been developed or proven viable. The company's claimed operating history since 2172 and references to future dates indicate that the business model is either fictional, speculative, or based on a timeline that does not align with current reality. The actual products or services being offered are unclear, and investors face substantial uncertainty regarding what they are actually investing in. If the company is operating as an entertainment, educational, or novelty concept rather than a legitimate space tourism venture, the market for such offerings may be extremely limited or nonexistent, and the company may never generate meaningful revenue or achieve profitability.

Red Planet Resorts currently has only one employee and very limited cash reserves. This minimal staffing level means the company lacks the human capital necessary to execute on its stated business plan, whether that involves developing entertainment content, managing a touring platform, or any other operational activities. The company is entirely dependent on this single individual for all aspects of operations, strategy, business development, and execution. If this person becomes unavailable due to illness, departure, or any other reason, the company would have no operational capacity whatsoever. Additionally, with only one employee, the company lacks the organizational depth to manage multiple business functions simultaneously, respond to challenges, or scale operations. The company does not maintain key person life insurance. There is substantial risk that the company will be unable to attract, hire, and retain additional qualified personnel necessary to build a viable business, particularly given its limited financial resources.

According to the use of funds disclosure, the company intends to use investor capital to launch 'The Mars Collective venture,' described as a multi-faceted entertainment platform designed to connect space-related organizations across various platforms. This represents a

significant departure from the company's stated business of operating Mars resorts and tours. The company has provided minimal detail about what this entertainment platform will actually consist of, how it will generate revenue, what specific products or services it will offer, or how it will compete in the entertainment or media marketplace. The business model appears to involve a national tour to drive social media growth, product sales, and consumer account creation, but the specifics of these activities and their revenue potential are unclear. Investors should be aware that they are investing in an unproven and poorly defined business concept that may bear little resemblance to the company's marketing materials. There is substantial risk that this pivot will fail to gain traction or generate meaningful revenue.

Red Planet Resorts claims to have served over one thousand happy visitors, won awards for its excursions, and sold out multiple resort locations through 2026. However, given that commercial Mars tourism does not exist and the company references dates in the future (2172) and future availability (2026), these claims cannot be verified and appear to be fictional or part of a narrative rather than actual business achievements. Investors have no reliable basis to evaluate the company's actual performance, customer base, or market acceptance. The claimed traction may be entirely fabricated or may refer to engagement with fictional content rather than actual paying customers for real services. This lack of verifiable operating history means investors cannot assess the company's ability to execute on its business plan or generate revenue. The company may have no actual customers, revenue, or proof of concept for any viable business model.

Red Planet Resorts has very limited cash reserves and will require substantial additional capital to develop and execute its business plan. The company has not disclosed any prior funding rounds or existing revenue streams that would provide financial runway. Given the company's minimal resources and single employee, the funds raised in this offering may be insufficient to achieve meaningful business milestones or generate revenue. The company will likely need to raise additional capital in the future, but there can be no assurance that such financing will be available on acceptable terms, if at all. The inability to obtain additional capital will restrict the company's ability to grow and may reduce its ability to continue business operations. If the company is unable to secure additional funding, it may be forced to curtail or cease operations entirely, resulting in a total loss of investment for current investors. Future financing rounds will also result in dilution of existing investors' ownership stakes.

Red Planet Resorts has not provided credible evidence of current revenue generation or a clear path to profitability. The pricing structure referenced on the company's materials suggests extremely low price points that would be inconsistent with any legitimate space tourism venture and insufficient to cover the costs of developing an entertainment platform or conducting a national tour. The company has not disclosed any existing revenue, customer contracts, or validated business model. The pivot to an entertainment platform concept is unproven and may not generate sufficient revenue to sustain operations or provide returns to investors. The company may continue to incur losses indefinitely, and there is substantial risk that it will never achieve profitability. Investors should be prepared for the possibility that the company will consume all invested capital without generating meaningful revenue or achieving a sustainable business model.

Red Planet Resorts intends to create an entertainment platform focused on space-related content and organizations, but the market demand for such a platform is entirely unproven. The entertainment and media industries are highly competitive, with numerous established platforms and content providers competing for consumer attention and spending. The company has not demonstrated that there is sufficient consumer interest in its proposed platform to generate meaningful revenue or user engagement. The concept of connecting space-related organizations across platforms is vague and may not address any clear market need or pain point. Additionally, consumer interest in space-related entertainment content may be limited to a niche audience, and the company may struggle to achieve the scale necessary for a viable business. The company faces substantial risk that its platform will fail to gain traction, attract users, or generate revenue sufficient to sustain operations.

If Red Planet Resorts proceeds with its entertainment platform concept, it will compete against well-established media companies, content platforms, and entertainment providers with substantially greater financial resources, brand recognition, technical capabilities, and market reach. These competitors include major streaming platforms, social media networks, content production companies, and specialized space or science entertainment providers. Many of these competitors have existing user bases, proven business models, and the ability to invest heavily in content creation, marketing, and technology development. As a company with minimal resources and only one employee, Red Planet Resorts will be at a significant disadvantage in competing for audience attention, content partnerships, and market share. The company may be unable to differentiate its offerings sufficiently to attract users away from established platforms, and may lack the resources to sustain operations long enough to build a competitive position in the market.

Red Planet Resorts' marketing materials present what appears to be a fictional space tourism business offering Mars vacations, while the actual use of investor funds is for an entertainment platform venture. This disconnect between marketing claims and actual business operations may violate federal and state consumer protection laws, false advertising statutes, and securities regulations requiring truthful disclosure. The company's claims about operating since 2172, having served over one thousand visitors, and offering actual Mars resort accommodations could be deemed materially misleading to consumers and investors. If regulatory authorities determine that the company has made false or misleading statements in its marketing or offering materials, the company could face enforcement actions, fines, penalties, cease and desist orders, or requirements to provide refunds to investors or customers. Such regulatory action could

result in significant legal costs, reputational damage, and potentially the shutdown of the company's operations. Investors could lose their entire investment if the company is found to have violated applicable laws.

Red Planet Resorts has not disclosed any patents, trademarks, copyrights, or other intellectual property protections for its business concept, brand, or content. The company's proposed entertainment platform and any content it creates could potentially infringe on existing intellectual property rights held by others in the space, entertainment, or media industries. Numerous companies and organizations operate in the space entertainment and education sectors, and the company may face claims that its platform, branding, or content infringes on existing trademarks, copyrights, or other protected intellectual property. Defending against such claims would be costly and could divert management attention and financial resources away from business operations. Additionally, without robust intellectual property protections of its own, the company may be unable to prevent competitors from copying its business model, content, or branding, which could undermine any competitive advantage the company might develop.

Red Planet Resorts has not disclosed any officers or directors beyond the single employee and founder. This absence of formal corporate governance means there is no board oversight, no independent directors to protect investor interests, and no separation between management and governance functions. All decision-making authority appears to rest with a single individual, with no checks and balances to ensure decisions are made in the best interests of the company and its investors. This lack of governance structure increases the risk of mismanagement, conflicts of interest, and decisions that benefit the founder at the expense of investors. Without a functioning board of directors or advisory board, there is no mechanism for investors to influence company strategy, hold management accountable, or ensure proper oversight of company operations and use of investor funds.

The founder of Red Planet Resorts has designated themselves as the lead investor who will sign on behalf of all investors in the special purpose vehicle (SPV). This arrangement creates a fundamental conflict of interest because the founder simultaneously represents the interests of the company (as its operator and controlling party) and the interests of the investors (as their designated representative). These interests may not always align and may often be directly opposed. For example, decisions regarding company valuation, terms of future financing rounds, executive compensation, use of company funds, timing of liquidity events, and numerous other matters may benefit the founder as company operator while disadvantaging investors. The founder will have access to material non-public information about the company's operations, financial condition, and prospects that other investors do not have, creating an information asymmetry that could be exploited. There is no independent third-party investor advocate representing the interests of crowdfunding investors, and investors will have no recourse if the founder makes decisions in their capacity as lead investor that favor the company over investor interests.

An investment in Red Planet Resorts is highly speculative and involves a high degree of risk. Investors should be prepared for the possibility of losing their entire investment. The company has minimal resources, an unproven and unclear business model, no demonstrated revenue or path to profitability, and significant questions about the legitimacy and viability of its operations. The securities being offered are suitable only for investors who can afford to lose their entire investment and who understand the risks associated with early-stage, speculative ventures. The company may never generate revenue, achieve profitability, or provide any return on investment. There is no guarantee that the company will successfully execute its business plan, and numerous factors both within and outside the company's control could result in business failure and total loss of invested capital.

The securities being offered are subject to a one-year holding period under federal securities laws, during which they cannot be resold except in very limited circumstances. Even after the one-year holding period expires, there is no public market for these securities and none is expected to develop. Red Planet Resorts is a private company with no plans to become a publicly traded company, and there is no established secondary market where investors could sell their securities. Investors should expect to hold these securities indefinitely and should not invest unless they can afford to have their capital locked up for an extended period with no ability to access it. The lack of liquidity means investors will be unable to respond to changes in the company's prospects, their own financial circumstances, or market conditions by selling their securities. Any eventual liquidity event, such as an acquisition or public offering, is highly uncertain and may never occur.

Investors in this offering will hold minority ownership stakes in Red Planet Resorts and will have no ability to control or meaningfully influence company decisions. The founder will retain control over all significant business decisions, including decisions regarding business strategy, operations, financing, acquisitions, sale of the company, and distributions to investors. Investors will have no ability to elect directors, remove management, or approve or reject major corporate actions. The founder will be able to make decisions that investors disagree with or that may not be in investors' best interests, and investors will have no recourse. This lack of control means investors must rely entirely on the founder's judgment, ability, and integrity, with no ability to protect their investment if they disagree with the direction of the company.

USE OF FUNDS

9. What is the purpose of this offering?

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$50,000**

Use of Proceeds: If only the minimum target amount is raised, Red Planet Resorts expects to use proceeds approximately as follows: 46% Mars Collective Platform Development, 27% National Tour Launch and Logistics, 19.1% Initial Social Media and Content Marketing, and 7.9% Wefunder fee and related offering expenses. Management intends to allocate proceeds as described but may adjust priorities based on actual costs, market conditions, and operational needs.

If we raise: **\$1,000,000**

Use of Proceeds: If the maximum offering amount is raised, including any oversubscriptions, Red Planet Resorts expects to use proceeds approximately as follows: 32% Mars Collective Platform Development, 23% National Tour Expansion and Venues, 13% Content Creator Partnerships and Outreach, 13% Space Agency and Brand Collaborations, 11.1% Merchandise and Duty-Free Product Inventory, and 7.9% Wefunder fee and related offering expenses. Management expects to deploy excess proceeds toward growth initiatives but may reallocate among categories as platform development milestones and partnership opportunities evolve.

DELIVERY & CANCELLATIONS

11. How will the issuer complete the transaction and deliver securities to the investors?

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

The intermediary will notify investors when the target offering amount has been met. If the Investor does not reconfirm, he or she will receive notifications disclosing that the commitment was cancelled, the reason for the cancellation, and the refund amount that the investor is required to receive. If a material change occurs within five business days of the maximum number of days the offering is to remain open, the offering will be extended to allow for a period of five business days for the investor to reconfirm.

Red Planet Resorts LLC is offering up to 500 shares of Class C Units, at a price per share of \$2,000.00.

The campaign maximum is \$1,000,000.00 and the campaign minimum is \$50,000.00.

Securities Issued by the SPV Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. While the Issuer may be required to pay an annual administrative fee for the maintenance of the SPV, investors should note the Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

This Agreement constitutes the entire agreement between the parties hereto with respect to the subject matter hereof and may be amended only by a writing executed by all parties. Pursuant to authorization in the Investor Agreement between each Investor and Wefunder Portal,

Wefunder Portal is authorized to take the following actions with respect to the investment contract between the Company and an investor:

Wefunder Portal may amend the terms of an investment contract, provided that the amended terms are more favorable to the investor than the original terms; and

Management's Discussion and Analysis of Financial Condition and Results of Operations

Overview of the Business and Financial Condition

The Company provides an immersive space-themed entertainment experience through a virtual journey to Mars and sells related space-themed consumer merchandise through its website and other retail and wholesale channels.

We are an early-stage company and have incurred operating losses and negative cash flows from operations since inception. We expect to continue to incur operating losses in the near term.

As of September 15, 2026, we had cash and cash equivalents of approximately \$2,000.

Our ability to continue operations is dependent on managing our expenses and, if necessary, obtaining additional financing.

This discussion should be read in conjunction with the financial statements and related notes included in this offering statement.

Business and Operating Uncertainty

Our business operates in an environment subject to various risks, uncertainties, and changing conditions, which makes it difficult to evaluate our business, financial condition, and prospects and may limit the comparability of our results of operations from period to period.

Financial Condition

As of December 31, 2025, our total assets were \$34,437 and our current and non-current liabilities, as reflected in available financial statement fields, were \$0.

Our financial statements reflect an early-stage company with limited operating history. Investors should not place undue reliance on historical financial information given the company's limited operating history and the likelihood that future results will differ from historical results.

Liquidity and Capital Resources

As of December 31, 2025, we had cash and cash equivalents of approximately \$2,098.

Based on our current operations, we have a monthly net cash burn of approximately \$5,000.

Our monthly net cash burn or profit may vary significantly from month to month due to the timing of receipts and expenditures and other short-term factors. As a result, period-to-period comparisons may not be meaningful.

Based on our current plan, we expect to have sufficient cash to fund operations for at least the next 12 months.

To date, our operations have been funded through minimal cash resources and have not included any external financing.

Liquidity Assumptions

Our assessment of our liquidity and ability to fund operations is not a projection and is based on current assumptions regarding operating expenses, cash requirements, and capital needs. These assumptions may change, and actual results may differ materially due to changes in operating conditions, timing of receipts and payments, and other factors.

Dependence on Additional Financing

There can be no assurance that additional financing will be available on acceptable terms, or at all. If we are unable to raise additional capital when needed, we may be required to materially reduce or suspend operations.

Indebtedness and Capital Structure

As of the date of this offering statement, we did not have any outstanding indebtedness.

(For the avoidance of doubt, SAFEs are not treated as indebtedness.)

We have not conducted any exempt offerings or raised capital in the past three years. We have primarily been funded by approximately \$216,000 in capital contributions from our founder.

The Lead Investor. As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that Investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an individual that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

In such circumstances, the Lead Investor may act as a portfolio manager for that Fund (and as a

supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company.
