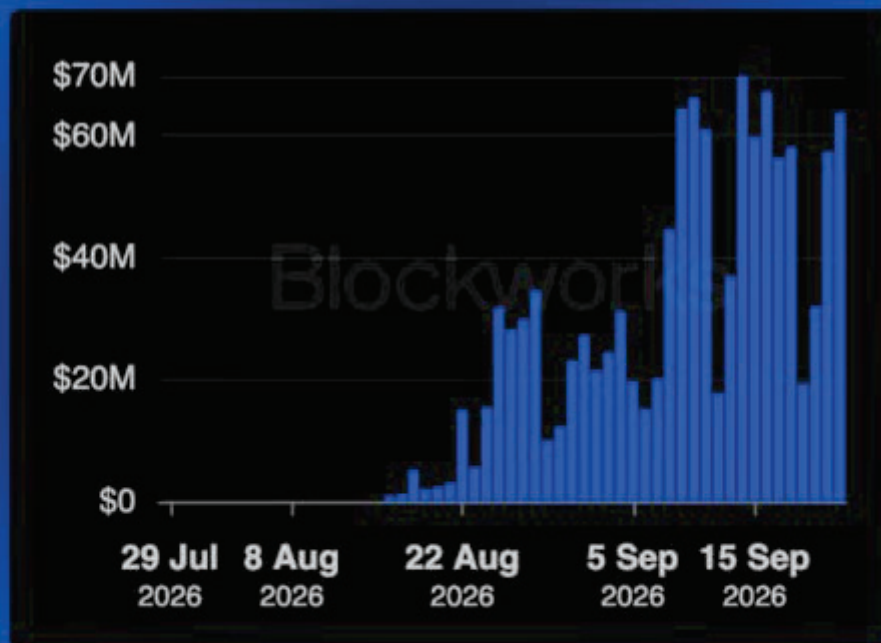

Coinbase Tokenized Stocks daily volume on Base

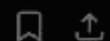

He has been the chief AI officer of [Meta Platforms](#) since 2025 and leads its [Superintelligence Labs](#).^[3] He is the co-founder and former CEO of [Scale AI](#), an artificial intelligence company that provides [data labeling](#) and [large language model](#) evaluation services to develop AI applications.^{[4][5]} In 2021, Wang became the world's youngest "self-made billionaire" at age 24.^{[6][7][8]} [Forbes](#) estimated his net worth at \$3.6 billion as of April 2025.^[9]
